On Tuesday, February 20th, the Bloomingdale Jaycees held their fourth annual "Citizen of the Year" awards dinner at Indian Lakes Country Club. Guest speakers for the evening were Norm Hoffman. President of the Illinois Jaycees and the Honorable Viola Morrisroe, Mayor of Bloomingdale.

Bob is founder and chairman of the Lions Marathon Run as well as membership chairman and deaf activities chairman.

Pat Sodomka is Civic Chairman for the Bloomingdale Women's Club, Administrator of the Friendly Corner Learning Center for Children, Chairman of Bloomingdale's Helping Hand Program, Assistant Editor of the Village Almanac, a Meals on Wheels worker, Sunday school teacher, and Outreach worker.

The Robert J. Homola Memorial Award was presented to former District 13 School Superintendent Harold Tompkins. Mr. Thompkins passed away recently at the age of 48. Accepting the award was his wife Pat. Harold was District 13 Super-

### **MAYOR TO RESIGN**

On February 5th Mayor Viola Morrisroe announced that she and her family will be moving to Canada sometime this summer. because of her husbands job transfer.

At the time of her announcement the Mayor requested the Board to call a special election for Mayor to be held simultaneously with the regular election of trustees on April 17th, She stated that she would be willing to resign prior to her move so that the Village could elect her replacement.

The Mayor also requested that if she resigned prior to April 17th, the Board would appoint an acting mayor to serve until the election, thus assuring continuity of authority in the Village's chief executive position.

After several weeks of discussion and requests for opinions from the Village attorney, the time passed beyond which a special election could be called concurrently with the general election on April 17th.

At this point in time the following facts are evident:

- 1. The Mayor will not resign until some time after the regular election.
- 2. Upon the Mayor's resignation the Board of Trustees will elect an acting Mayor. The person so elected could then serve out the balance of the term of office until April 1981 unless the Board votes to call a special election to fill the office for the same period of time.
- 3. If the Mayor does not resign until June, a special election could not be held until the end of September since a special election under these circumstances would require at least 90 days.

To date neither party has announced whether or not they would seek a special election should they obtain a majority on the Board.

# "PROJECT CONSERVE" TAKE TIME TO SAVE

How much are your home energy sources costing you? How can you cut these costs? How can you conserve energy?

To provide residents assistance in answering these questions, the Illinois Institute of Natural Resources has prepared a survey as part of their "Project Conserve." (Survey stapled to center of ALMANAC)

If you complete the survey and return it to the Institute, within three weeks they will send you a computer processed assessment prepared especially for your home. The Printout will recommend conservation measures, their cost and tha time required to get back the initial cost in savings.

A typical home analyzed in the Village showed that electricity costs rose 63% from 1975 to 1978; natural gas costs rose 64% for the same period. The total dollar increase was \$426.91.

So take the time to complete the survey and mail it to the Institute. Your investment in time plus the 15-cent stamp could return sizable dividends.

### **SNOW COSTS MONEY**

It may "rain pennies from heaven," but when it snows it is expensive! For the 1978-79 season total cost for snow removal and salt amounted to \$64,373.04 (through March 8); this compares to \$32,977.30 for last year and \$13,585.19 for the previous year.

Federal Disaster aid may be approximately \$21,700. Even so the net cost would still exceed \$42,600.

The significance of these costs is that this year we will have spent approximately 7½ times the amount spent on plowing two years ago without any increase in the territory being plowed.

Not included in these dollar amounts is the cost of equipment repairs, gas and oil and equipment deterioration not to mention the frazzled nerves and fatigue endured by the Department of Public Works and the Village Staff.

### "911 PROGRAM"

The Board of Trustees designated Police Chief McMahon as the Village's liaison for the "911" Implementation Study which was approved by the DuPage County Mayors and Managers Conference. (See Chief's Corner)

### **COMMISSION APPOINTMENTS**

Three members of the Economic Development Commission were reappointed to three-year terms expiring on February 1, 1982. They are Messrs. John Best, Dominic Casalina and Al Radcliffe.

The Board also agreed to accept the resignation of Mr. Raymond J. Friscia as a member of the Youth Commission.

Mr. James Gebis was appointed to a term on the Zoning Board of Appeals which will expire on May 1, 1980.

# CHANGE MINIMUM AGE FOR LIQUOR PURCHASE

The Board passed a resolution on February 12 recommending to the State Legislature that the minimum age for purchasing package liquor be changed back to age 21. Chief McMahon stated at the Committee Meeting that the primary problem is packaged liquor purchases. Also, there has been increased vandalism because there is no one to monitor these individuals when they drink outside. He stated that if nineteen and twenty year olds are drinking at a bar and are monitored by a reliable bartender, few problems arise.

Village Administrator Bob Reeves pointed out that the Village has had seven contacts with liquor violations; five have dealt with package liquor and two with pouring (not necessarily with juveniles).

(Because Bloomingdale does not have Home Rule, the Village has no authority to change the law; however, at press time changes to the law were being discussed in the State Legislature. Editor) The Village Almanac is published bi-monthly by the Public Relations Committee of the Village of Bloomingdale.

# INDIAN LAKES SEWER PROJECT INITIATED

On March 5 the Board of Local Improvements unanimously agreed to hold a public hearing on March 24th at 1 PM to consider the installation of sanitary sewers for "East" Indian Lakes. The date was set after George Wight, Consulting Engineer to the Village, had reviewed the schedule and expenses with the Board.

The area involved is bounded by Schick Road, Bloomingdale Road, Army Trail Road and Cardinal Drive.

The project was first studied by Mr. Wight last summer after the Mayor had surveyed the residents of all of Indian Lakes and determined from the results of the survey that the west half of Indian Lakes, opposed by a large majority, the installation of sanitary sewers.

At the meeting on March 5, Mr. Wight estimated total cost for the project at slightly over \$1.9 million dollars. This amount would be shared by the 320 property owners with some of the expense paid for by the Village because of public benefit. Additionally property owners would have to pay tap-on fees plus the cost of running the sewer line from the house outlet to the street.

Construction will involve the open trenching and placing of approximately 43,000 feet of sewer pipe. Restoration of the streets and driveways will be completed after the installation of the eight miles of sewer lines.

At the meeting Mr. Wight stated that the costs were based on bids being received in early December of 1979. He also stated that any stepping up of the process which includes public hearings, notice and appeal of assessments, and letting of bids would obviously save the taxpapers money because of the continued inflation rate.

If everything goes according to the schedule Mr. Wight proposed to the Board of Local Improvements, construction could begin in December of 1979.

Affected residents were notified by the hearing by registered mail.

"An egg route started it all," stated Jack Warnimont wistfully, as he talked of the fifty years his family has been in business in the community. In 1929 his parents sold feed in the Roselle area; in 1946, the Warnimonts opened their hatchery and farm store on Lake Street.

But 1961 saw an end to the hatchery; the wheels of the feed grinders came to a halt soon after as the farmers began to leave the Bloomingdale area.

"We needed an alternative; so, in 1961 we joined the Tru-Value people and began our hardware business."

Business has never been the sole interest of Jack Warnimont. Ten years on the volunteer fire department, a boy scout leader, a member of the Board of Directors of the Bloomingdale State Bank and the Marklund Home have kept him involved in the community he has seen grow over the last fifty years.

When asked about this growth, in terms

of new businesses and homes, Jack quickly responded, "You need to adjust to it. I have mixed emotions when I look back and remember how Blooming-dale used to be. I have so many good memories. ### **CHIEF'S CORNER**

"Help, my husband has just had a heart attack. Can you send me an ambulance immediately!" In instances such as this or any other emergency, swift response by the appropriate agency is essential. Often it is the difference between life and death.

The total time required in response to an emergency situation is the sum of the following time periods:

- The time the citizen perceives an emergency to the time he or she reaches the <u>correct</u> public safety agency;
- The time the <u>correct</u> agency receives the call to the time that agency can dispatch an emergency vehicle to the scene; and
- 3. The time it takes for the vehicle to arrive at the scene.

Obviously the first factor is most critical since it triggers the subsequent steps.

And yet, according to surveys conducted by SRI, a California research firm retained by the DuPage County Mayors and Managers to analyze this problem, less than 50% of the citizens knew the telephone numbers of their own public service agencies such as the Police or Fire Department. Furthermore, more than 20% did not even know who the correct agency was to contact.

Average call delays for citizens experiencing emergencies and not knowing the correct number ranged from 1 to 3.5 minutes. Fully 20 percent of those surveyed had an average delay of 3.5 minutes.

These large delays (often longer than the average measured Bloomingdale Police emergency response time of 2.5 minutes) in citizen access to public safety agencies are caused by citizen confusion about agency identification and the lack of easily located emergency numbers.

And when people are out of town or traveling, very few would know the appropriate agency to contact, much less the emergency telephone numbers of these agencies.

Many cities have already incorporated a solution to this problem, commonly referred to as "Nine One One," a number that any one can call in the event of an emergency.

# FANTASTIC RESPONSE TO BLOOD DRIVE

Some gave "...a damn (and)...a pint"; some gave time and some even gave a gallon! Altogether, it was more than enough as Bloomingdale residents donated a total of 513 pints of blood in three drives held since last fall. This surpassed by 61 pints the number required to insure that adequate blood will be available for all Village residents. Our "premium" is now paid through October, 1979.

"The response was fantastic" on all levels according to Donor Recruitment Chairman Natalie Merkel. Speaking on behalf of the Association, Merkel thanked all those who donated, called, worked, walked and contributed to the "exhilarating success" of the Blood Assurance Program.

Special, recognition was accorded five donors who have given a gallon of blood or more. Those awarded "Gallon Donor" pins on March 10th are: Robert Anderson of 239 Tamarack Drive; William Brannan, 217 Oakwood; Michael Grant, 272 Langton Lane; Reuben Kuznitsky, 256 Cunningham; and Beverly Scharlau, 132 W. Lake Street.

Anyone needing blood replaced or information about the program may call the Village Hall or Association President Sandi Scesniak at 894-4653.

Recognizing the immense public benefit of this program, the Illinois Legislature passed Public Act 79-1092 which requires that the 911 System be operational throughout the State of Illinois by December 31, 1985.

Why should it take so long, you may ask. Several problems arise. For example the Bloomingdale Fire Protection District is responsible for part of Glendale Heights. Using a central point of dispersal, how do you keep all of the boundaries in mind?

The answer to this and other problems with the system will be the topic of my next article. I can assure you that as the Village's designated liaison to the 911 prorgram in DuPage County, I will do everything to initiate its quickest implementation.

In the meanwhile, know your emergency services numbers. In any emergency within the Village, call the Police Department emergency number 529-3341.

### **ATTENTION SENIOR CITIZENS**

Many helpful programs are not available specifically for senior citizens, according to Doris Karpiel, Bloomingdale Township Supervisor. Questions concerning any of the programs listed below can be answered by either Doris Karpiel or Shirley Williams at the Township Office, 529-7715. Office hours are 8:00 AM to 4:30 PM Monday through Friday. The mailing address is 123 N. Rosedale Road, Bloomingdale, IL. 60108.

### **CHORE/HOUSEKEEPING GRANT**

Bloomingdale Township has received a grant through the Illinois Department on Aging to provide free help to township senior citizens with some of their household chores. Such tasks might include house cleaning, snow shovelling, gardening, laundry, etc. To obtain these services, the senior citizen must obtain an application from the Township Office.

Ms. Karpiel has also stated that the Township will hire qualified unemployed youths between 13 and 17 and living within the Township to perform these tasks at a rate of \$3.00 per hour. Senior citizens with special skills and willing to help in this program are also encouraged to apply.

### **MINI-BUS SERVICE**

Township citizens who are 60 years of age or over or are handicapped may obtain a pass to use either of the two minibuses provided through the Ray Graham Association for the Handicapped. After receiving a pass, the user need only call the Township Office to make arrangements. They request one-week's notice when a doctor's appointment must be kept.

### V.I.P. CARDS

Retired persons aged 60 and over are invited to become members of the V.I.P.'s, a non-profit organization whose purpose is to provide social activities either free of charge or at low cost to members as well as offer discounts on purchases from businesses participating in the program. The V.I.P. card is recognized nationwide.




The most important goal I feel that we need in the Village is efficient executive and line management performance, thereby continually saving tax dollars to at least equal to the ever growing inflation rate.

Since my family and I moved here in 1973, we have enjoyed and appreciated the sense of community that sets Bloomingdale apart from the usual "suburb." We have recently reinforced our commitment to Bloomingdale by purchasing a home in the Old Town Estates section.

Up until now, we have been somewhat frustrated by the lack of shopping facilities and the resulting inconvenience. Now, thanks to the leadership of Mayors Morrisroe and Homola, Bloomingdale will soon enjoy a rapid commercial expansion.

While that expansion will solve many problems, and increase revenues, it will also significantly increase our exposure to overspending. As a member of the Capital Improvements Commission, I have helped develop a five-year forecast of revenues and expenses

### SCHOOL BOARD RACES

With the current school year turning into the home stretch, local school board elections are also caught up in the race.

In District 13, which covers DuJardin and Central elementaries plus Westfield Junior High School, there are three positions open for the April 14th election. One is for a two-year term and the other two are for three-year terms. At press time the only person to file is incumbent Marvin Roehlke of 256 Tee Lane who is seeking a three-year term.

### PARK DISTRICT ELECTION

Two candidates have filed for the one Commissioner's seat to be filled at the April 3 election. Ralph W. Johnston has served approximately six years as one of the five commissioners. Larry W. Roberts, a resident of Seasons Four in Roselle, is also running for the position.

Two polling places will be open from 6 AM to 6 PM for registered voters: the Park District office on Circle Avenue in Bloomingdale and the clubhouse at Seasons Four in Roselle. The last day to obtain an absentee ballot by mail is March 29; the last day to obtain an absentee ballot in person is April 2.

Elections for District 13 will be held on April 14 at Central School, 112 Day Street, from 12 Noon to 7 PM.

District 15, covering Black Hawk and Winnebago elementaries plus Marquardt Middle School and Marquardt Special Education Center, has four candidates who have filed for three three-year terms and one one-year term.

Candidates for the three-year terms are Barbara Newton of 1418 Terry Road (Glendale Heights), Earle Holmes of 822 King Point Drive (Addison), and Raymond Beier of 450 Norton St. (Glendale Heights). Filing for the one-year term is Margaret Shiner of 316 Bridgewater (Bloomingdale).

Elections for District 15 will be held from 10 AM to 7 PM on April 3 at Winnebago and Hall Schools.

The Board Election for Lake Park High School will be on April 14. At press time we had no further information on this race.

Have you ever sent a special gift to a friend or loved one and received a call several days later thanking you, but apologetically asking you what the present was before it was smashed into a million pieces?

According to Jim Sutter, Bloomingdale Postmaster, much of the problem orginates with the sender rather than with the Postal handling. Seldom do problems arise when the package is properly packed.

The first step in successful packaging is to use a strong fiberboard carton. Many carton manufacturers display a burst test number. This number indicates the relative strength; the higher the number, the stronger the carton.

Another important step is to pack the article so it will not move around in the box. Although the old standby is rolled up newspaper, Jim suggests using popcorn-unbuttered of course. The popcorn is lighter and retains its stability better.

In securing the package, use pressure sensitive reinforced tape. Masking tape is discouraged since it tends to peel and has little strength. Nor should you use wrapping paper and string. Many a person has used wrapping paper only to find that the address has blurred on the paper or has torn off in shipping. The Post Office doesn't enjoy having twine fouling up their conveyor systems.

For addressing the package, the Post Office prefers mailing labels with the address covered with transparent tape. Also be sure to enclose a return address inside the package in case it is broken or damaged.

Lastly, before taking the package to the Post Office, make sure that all other addresses have been scratched out.

Parents who need after school care for their children will find help offered through the Bloomingdale Township Child Care Services program.


Incorporated in March of 1978, the BTCCS opened its first after school child care program, the Children's Center, at Winnebago School, 195 Greenway Drive, in September of 1978. The program is designed primarily for families of low and moderate income in Bloomingdale Township, but child care is available to everyone. A sliding fee scale based on income is used to determine cost to the parents.

Karen McFedries, the site director, has planned a program consisting of a nutritious snack, active exercise and passive activities, as well as time to do homework. Mrs. McFedries' qualifications include a degree in child and family studies, work with Catholic Charities in its foster care program, and work with abused and neglected children.


The Child's Center qualifies for federal matching funding; In other words the government will match funds contributed by community businesses and organizations that support the work of the Children's Center.

To date, Austin Federal Savings and Loan Association, Bloomingdale State Bank, Bloomingdale Women's Club, and Blue Ribbon Realty have provided such support. A major source of funding has been seed money from the DuPage Child Care Association.


