## PARK DISTRICT BOND REFERENDUM MAY 31

The Bloomingdale Park District has set May 31, 1980 as the date for their referendum to ask taxpayers to approve the borrowing at \$400 thousand in General Obligation Bonds to construct a new field house.

The proposed 9100 square foot facility would be used for all indoor athletic programs presently sponsored by the District.

The gymnastic facilities for programs previously have been available through cooperative efforts with School Districts 13 and 15; however, the increasing enrollment in these districts has severely limited the use by the Park District of such facilities. Additionally School District 15 has been charging fees for facility use as well as janitorial service.

Architects for the building are Art Jakl & Associates. They have recommended concrete slab construction for the 65 foot by 140 foot structure, which will be located immediately south of the existing Park District offices at 172 South Circle.

By locating the building on this site, the existing shower facilities which are presently only used during the swimming season would also serve the field house.

Municipal Finance Consultants to the District Paul D. Speer & Associates have indicated that the approximate annual cost to the taxpaper would be \$5 per \$10 thousand assessed valuation. According to Park District Director, Thomas G. Lovern, for the average home in Bloomingdale the cost would be something less than \$10.00 per year for the 11 years of the bond's life.

Assuming approval of the referendum, the Park District would hope to have construction begun by September 1 and gain occupancy by the end of 1980.

# WORTMAN REPLACES FOCKLER AS VILLAGE TRUSTEE

On April 15, the Village Board voted to have Victor A. Wortman of 184 Jackson Lane fill the trustee position vacated by the resignation of David B. Fockler on March 11.

Fockler had previously advised the Board that he would have to resign sometime in the first quarter of 1980 as his company's headquarters were being relocated.

Dave had been elected to a four-year term on April 17, 1979 along with trustees Lehr and Robinson. Previously Dave had been a member of the Capital Improvements Commission.

Mayor Tenuto accepted the resignation with regret stating that Fockler had proven to be an asset to the board in the short time he has served as a trustee.

Vic Wortman, a native Californian, earned his B.A. in Psychology from U.C.L.A. in1966. After graduation he

joined McDonald's System, Inc. as a store manager trainee,

By 1968 he was a field service consultant and in 1971 was promoted to Western Region Field Service Manager. In 1972 Vic was appointed National Training Director at McDonald Headquarters in Oak Brook. At that time he and his family moved to Bloomingdale.

In 1973 he was appointed Director of Product Development and in 1975 he became Director of Quality Assurance. He is currently responsible for the quality of approximately \$2 billion in food purchased worldwide by the McDonald Corporation.

He and his wife Dorothy have three sons: David, 14; Aaron, 11; and Matthew, 5.

According to state law the appointment is only until the next regular Village election which will be held in April of 1981.

# REVISED LIQUOR CONTROL ORDINANCE

After several weeks of consideration the Board of Trustees revised the Liquor Control Ordinance which now prohibits anyone under the age of 21 from dispensing alcoholic beverages; however, the ordinance does not prohibit the serving of alcoholic beverages by anyone 18 years of age or older. With the growth of the Indian Lakes complex and the need for summer help the Board felt that the restriction against dispensing of alcoholic beverages was sufficient control without eliminating many local youths between 18 and 21 from holding jobs at the golf resort.



What is in the future for Bloomingdale? "With its centralized location and concerned citizens and business people, only good things can happen for Bloomingdale."


His pride and optimistic outlook for the future of the Village is expressed in more than words, however. He recently purchased four acres of land adjacent to his present headquarters for future expansion

## **CABLE TV UPDATE**

The villages of Bloomingdale, Roselle, Wood Dale, Itasca and Bensenville have formed a committee to jointly solicit proposals and research the possibilities of Cable TV. Carol Stream has indicated they may also wish to participate.

The joint committee plans to send out "request for proposal" to interested Cable TV companies in April, receive the the proposals in May and consider them in June.

When there is general agreement that 3 to 5 companies can meet the main critera, further studies will be confined to this group.

After isolating the strongest companies in terms of financial capabilities and experience, the villages involved can then select the company to consider for a franchise.

According to Village Administrator Bob Reeves, the committee hopes to have a specific company considered for a franchise by the fall of 1980.

## SOLICITORS WELCOME??

Spring not only brings sunny days, green leaves and colorful flowers, but also for many it brings an unwelcome sight — the door-to-door solicitor.

In 1971 the Village passed an ordinance stating that any individual or firm wishing to solicit in the Village must first register at the Village Hall. The Individual registering is given a certificate of registration which is only valid for the time period stated on the registration card. The solicitor must be able to produce the card at the request of the homeowner being solicited.

Soliciting is limited to the hours between sunrise and sunset; furthermore, no soliciting is permitted on any state, national or legal holiday.

For the convenience of those residents who do not like to have their activities interrupted by such solicitors, the ALMANAC has provided a "No Solicitors Invited" card which the resident may placed on or adjacent to his front door. Any person soliciting a residence displaying this card is in violation of the ordinance and may be cited by the police for violation of the ordinance.

## Library Receives Grant

The Bloomingdale Public Library has been selected by the state of Illinois to receive \$2,407.58 in the form of a "Per Capita Grant." Per Capita Grants are recommended and supported by the Illinois Library Association, and provide direct grants to public libraries that meet application criteria. The grant is based on 21.3¢ per person for the population of Bloomingdale, based on the 1978 Special Federal Census.

The Bloomingdale Public Library Board of Directors has earmarked the grant for reference materials and periodicals on microfilm. Demand is particularly heavy for these materials by both students and adults. The library will continue to strengthen its collection and services so that it may better serve as an information center for the whole community.

## Art Available

With the arrival of spring, most people are taking time to clean and spruce up their house or apartment. A good, inexpensive way to create a new look for your home or office is by checking out framed art prints from The Bloomingdale Public Library, which are available through the DuPage Library System.

The prints can be selected from a catalog showing color photos of the subjects, their sizes, and descriptions of the artists' backgrounds. Famous artists such as Monet, Picasso, Cezanne, O'Keefe Toulouse-Lautrec, and Degas are but a few of the 600 available prints. ## SENIORS: AN OFFER YOU CAN'T REFUSE

If you are a resident of Bloomingdale Township and 60 years of age or older with hedges to be trimmed, grass to be cut or even windows to be washed, the Township is making you an offer you can't refuse.

The Seniors Chore/Housekeeping Program provides senior citizens the services of qualified workers, for FREE!

Senior Service Director Shirley Williams explained that the Township employs about 200 youths between the ages of 14 and 17 — and some retirees — who will perform a variety of chores around the house such as light housekeeping, light repair work and land-scaping such as grass cutting, shrub trimming, etc.

Upon completion of the work requested, the senior citizen is asked to pay

the worker(s) \$3 per hour. The Township then reimburses the senior citizen for the full amount paid. Williams stressed that special arrangements can be made for seniors who cannot afford to pay when the services are rendered.

Senior citizens who want work to be done as well as youths who want to work should contact the Township office at 529-7715. Interested parties will be matched up based on location and type of work required.

As Director Williams stated, "The program is as great for the kids as it is for the senior citizens whom they help. It not only offers them paid employment but teaches them valuable interviewing skills as well.

Last year the program logged 6900 hours of service within the community.

## DOG DAYS OF SUMMER

While a dog may be man's best friend, to the postal carriers who must confront the snarling beast, the canine species can pose a real threat to the carrier's health and well-being.

According to Bloomingdale Postmaster Jim Sutter the incidence of dog bites is especially high during summer months.

Jim attributes this to the fact that more doors are open, more pets are outside, and conditions are just right for pets to put in for the neighborhood "blue fang" award by ripping away at the nearest postal uniform . . . and the wearer thereof.

Although the vision of a dog nipping at a postal carrier who is trying to dodge clear of the animal may be humorous to some, of the post office and other delivery agencies the problem is becoming increasingly serious.

The real problem is not the dogs. The problem is with the owners of these pets who do not exercise proper control over them. It is not just the big dogs — little dogs can bite, too.

Sutter states that the persons most often bitten by dogs are the postal carriers, whose only objective is to deliver your mail safely to you and get away in one piece.

In addition, a threatening dog can directly affect the receipt of your mail. Postal regulations state that if an unrestrained animal threatens a carrier's safety at a particular residence, the postal carrier is not required to risk injury in attempting to make delivery. Further, in such instances mail service may be curtailed to that residence and not resumed until such time as the owner of the dog provides the post office with written assurance that the animal will be controlled in the future during delivery bours.

Furthermore, when such incidents do occur, the delivery personnel are encouraged to file suit against the owners of such animals.

Effective control of personal pets, however, is the most effective safety precaution a resident can take to keep everyone happy, and assure prompt, continuous delivery of mail.

# CONSUMER COMPLAINTS HELP AVAILABLE

Bloomingdale residents who think they might have received the rotten end of a transaction can now take their complaints to the consumer complaint office in Bensenville.

Located at 1339 West Irving Park Road, the full-time office is open to anyone in DuPage, Northern Kane and parts of Western Cook County, who wishes to file any complaint contained under the State Consumer fraud Act.

According to Helen Spelty, office manager, complaints may vary from unrequited goods and services to any problems relating to "automobiles, heaters, insulation, home repairs, or mail order fraud."







# GOOD HOUSEKEEPING PREVENTS FIRES

According to Chief Koehn of the Bloomingdale Fire Department, good housekeeping habits are the key to preventing fires. A homeowner would be wise to keep his attic, basement and garage uncluttered. In addition, stairways and exits in the home should be free of unnecessary items so they can provide unimpeded escape in the event of a fire.

Many people will be doing Spring cleaning in the next few weeks and may find that this is the time to do a little extra cleaning to help prevent fires. Flammable liquids and other flammable items should not be stored in areas which get warm or lack proper ventilation. For example, store flammable items 5-10 feet from the furnace. When storing items in attics, pack them in cartons instead of lying loose. Use the attic for long-term storage only if the attic receives proper ventilation.

With barbecue season approaching, make sure that any waste container used for disposal of warm or hot ashes should not be combustible or near combustible items. The container should not contain any items which could ignite.

As always, smoke alarms and fire extinguishers are important items to install in the home. Homes with several levels should have an escape ladder. If you have any questions concerning the prevention of fires, call the fire department at 894-8488, the non-emergency number.

Speed limits on state controlled highways are conditioned upon many factors, such as width of pavement lanes, number of turning movements, number of accidents and casualty losses, types of accidents, number of total vehicles using highway, loss of life in accidents and others; but the State of Illinois has the sole jurisdiction in setting speed limits on any highway controlled by the State.
