



## Meeting the Challenge of the "80's" (Mayor Tenuto's Annual Report)

Every year Mayor Samuel J. Tenuto has prepared an annual report to the Board of Trustees and the people of our Village regarding the Village's accomplishments and future goals. This year the Village Almanac asked Mayor Tenuto if he would present this annual report via the format of an interview. The interview took place on January 8, 1982, and follows:

**Almanac:** Mr. Mayor, we'd like to talk with you today about the achievements made during the past year and your goals for our Village for 1982.

**Mayor Tenuto:** To begin, I would say that 1981 was the most notable year ever seen by this Village with respect to the number and scope of goals we saw successfully realized. We made progress especially in the areas of meeting the challenge of more complex planning and finance situations. As a result, there will definitely be a positive long range effect on the future development of our community.

**Almanac:** Is there one particular accomplishment that stands out the most in your mind?



**Mayor Tenuto:** They were all important, but of course the most obvious in size and impact was the on-schedule completion and opening of the Stratford Square Shopping Center. It's not likely that Bloomingdale will see the likes or magnitude of such a project again. As the four major department stores and 102 mall stores were open for business on March 9, 1981, we believe it was the largest simultaneous opening in the State.

Currently, the mall is about 83% occupied with 154 tenant spaces filled, plus the mall has been designed for future expansion.

From my personal viewpoint, the opportunity to work on the Stratford project was most gratifying, an experience I'll long remember. And for all of Bloomingdale the benefits are quite substantial, we have gained an assurance in terms of future financial stability.

**Almanac:** Certainly the opening of Stratford made 1981 an unprecedented year, but what about some of the other goals completed in 1981, such as roads?

**Mayor Tenuto:** Phase II of our Road Program was completed. The major reconstruction took place in October and November and was completed on schedule as well as within the project budget of \$300,000 despite the large machinery strike during the year.

Another road project just recently approved by the County Board is the \$3,475,000 widening of Bloomingdale/Roselle Road from Lake Street to Irving Park Road. This road improvement will alleviate the congested traffic problems that are experienced along that section.

The County agreed, early in 1981, to provide the local share of the construction, provided that Federal monies were secured. But in December, 1981, in order to speed up the project the County offered to pay all costs except for legal and engineering, which is estimated at \$325,000. We're very pleased to be joining hands with Roselle in splitting that amount as both Villages will benefit. We are also grateful to Jack Kneuper and our local county officials for their cooperation in working with us on this project.

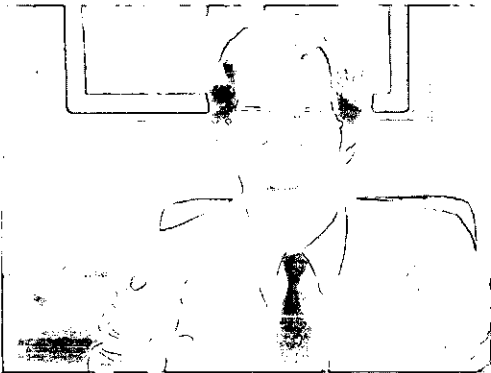
**Almanac:** It will be good to have that congestion at the intersection of Lake and Bloomingdale relieved. Speaking of Bloomingdale Road, what was all that construction with the sewers north of Lake Street?

**Mayor Tenuto:** That was the North Old Town C.D.C. Sewer and Water Project. The Village received \$370,000 from HUD for that work. Actually, that was the last of a block grant of \$840,000 to the Community Development Commission of DuPage County. Now sewer and water service will be available to lots along Park Street, Walter Court, and Bloomingdale Road in the Old Town District south of Meacham Grove Forest Preserve. The construction should be completed in early 1982.

**Almanac:** Last year's forecast also listed the completion of the Indian Lakes Drainage Project. Was that finished?

**Mayor Tenuto:** Yes, indeed, Special Assessment #4, as the project was called, was finished, and this will provide that subdivision long overdue relief from the flooding conditions during heavy rainfall.

Another completed project in part of Indian Lakes was the installation of sanitary sewers to 36 homes. Working with these residents, the Village has utilized what is



termed the Special Service Area financing method. In addition, there was a pleasant bonus because the Village was able to take advantage of the low bid accepted for the construction and, subsequently, we were able to abate the amount of money required from the homeowners to pay for the project for the first year.

**Almanac:** I'm sure those residents were pleased about that. It's been said that Lake Michigan water is coming to Bloomingdale. Where do we stand on that at this time?

**Mayor Tenuto:** We are very aware of the future water problem and have been planning to provide this service to the community. We have joined the DuPage Water Commission which gives us greater bargaining power along with other communities as a group. In the meantime, however, we did totally rehabilitate Wells #2 and #7 this year to help insure adequate water supply for the more immediate future.

**Almanac:** Do we know yet how much it will cost to bring the water out here?

**Mayor Tenuto:** Well, the cost of the water has been estimated by various sources in different amounts and there are various elements of the cost: constructing pipeline



to and through various municipalities, various costs to the Village for storage, pumping stations, system additions, etc., as well as user fees. You can see why this is taking a

lot of attention now so that the costs can be spread out and not be impacted all at once. I have directed our Finance Commission to thoroughly investigate the total aspects of financing with respect to the eventual cost.

**Almanac:** What kinds of progress has been made during this past year in other areas of finance?

**Mayor Tenuto:** As they relate to yours and my wallet, right? We did rather well. First, the Public Benefit portion of the Lake Street sewer and water project was abated for the 4th year in a row, and second, the 1974 Road Project General Obligation Bonds have been abated for the 7th year. The combination of these two abatements of \$138,462 will have a positive effect on our 1981 property tax bills.

**Almanac:** That's encouraging, that makes three abatements although Special Service Area #1 will affect only those particular homeowners. How much of a reduction will we see in the Village's property tax?

**Mayor Tenuto:** Let me give you an example — for a home assessed at \$20,000 there will be a savings of about \$24.00 of the Village portion of the property tax. This does not reflect the increase, however, attributable to the construction of the new library building which was approved by the residents via a referendum.

**Almanac:** What other financial changes have there been?

**Mayor Tenuto:** There are a few areas within the administrative workings of the Village where we have managed to save the residents some money. First of all, the Village has become a member of the Intergovernmental Risk Management Association. This is a group insurance plan consisting of several municipalities. Our cost for coverage will go from \$120,000 down to approximately \$54,000. And we will also have broader coverage and higher limits of liability for greater protection.

In the Police Department we instituted the Community Service Officer Program at no cost to residents. This program frees the sworn officers to handle the more serious problems. In addition we feel the increased visibility of the officers serves as a deterrent to potential problems. While I'm on the subject of the Police Department, I'd like to mention that through their excellent foresight and planning we have been able to minimize some of the

problems that almost certainly accompany the arrival of a large shopping center. They are to be commended.

**Back to finances** — we have had a whole new area open up, Industrial Revenue Bonds. There are several commercial and office developments currently seeking these bonds and we have been able as a Village to work closely with commercial enterprises in seeking this form of financing. It's one more viable avenue to enable business to locate here and enhance the degree and quality of our growth.

**Almanac:** Perhaps this is an unrelated question, but I'm curious. We've talked about the IMRA policy, C.D.C. funds, the DuPage Water Commission, and the Bloomingdale/Roselle project being largely funded by the County — all beneficial entities to the Village. How have we managed to get in on all of these?

**Mayor Tenuto:** You get the Village involved in a constructive manner, that's how. Bloomingdale is a very secure Village, but by no means are we an island. We must evaluate the problems affecting all of DuPage with respect to the impact on us. In turn, we must contribute time and energy to guarantee the good of the whole area in order to safeguard our own. There are direct avenues open to do this. I serve as a Commissioner on the County's Regional Planning Commission and I'm a Director on the DuPage Mayors and Managers Conference. And the Village does benefit from my working with other governmental bodies, it brings back a fair share of benefits. Then, we have a Village staff which is very much "on the ball" in researching various programs available.

**Almanac:** Are there any other goals reached in 1981 you would like to mention before we move on to 1982?

**Mayor Tenuto:** Yes, a major achievement was a total modernization of our Commercial Zoning Ordinance. The revised code will go far in assuring a high level of quality commercial development within our Village.

One area where it's already noticeable is the Merchant's Park area by Stratford Square. Pearle Vision and Burger King are presently located there with McDonald's and Meriweather's Restaurant to come. All the buildings there as well as the landscaping will provide a unique character within the shopping environment while keeping within the image we strive to maintain in Bloomingdale.

We've also completed Phase I of the Landscaping Plan within the Village. Two important areas finished are the grounds around the treatment plant and the island at Edgewater and Bloomingdale. We do plan to add further enhancements when the funds are available. It will be an on-going project. In addition, I will ask the Village Board to implement a tree planting program in the community this year and we'll have further details on that project a little later in the year.

Overall, we have had a very good year, more accomplished than not, and more on target for the long-range return. Looking forward, our work is cut out for us. There are numerous opportunities ahead to enhance our environment.

**Almanac:** Is there one objective for 1982 that you would put at the top of your list?

**Mayor Tenuto:** Just one? No, we're beyond the stage to single out one. The key, however, I feel to implementing both the 1982 programs and those to follow is the continuation of sound financial planning. This is the major priority.

**Almanac:** How do you see Stratford Square affecting the Village tax rate?

**Mayor Tenuto:** First of all, our property tax, exclusive of the Library tax, is currently at the same level as last year due to the abatements. Second, we will see a very gradual decline of the tax levy, once again the key being sound financial planning. It will be a gradual decline due to the fact that 50% of the sales tax revenue will be going to pay Urban back for the funds they advanced the Village to complete our share of Wheaton and Schick Roads. Once that debt of \$2,622,000 is retired, in approximately five years, the sales tax will make a most notable dent in our property tax bills.

**Almanac:** What about further commercial and housing development this year?

**Mayor Tenuto:** The newly formed Comprehensive Planning Commission, consisting of five trustees, continues to work with the Plan Commission and the Village Planner to uphold the quality of development to meet our current level of standards. Urban plans on building 3,500 housing units over the next ten years and we will continue to work with them to ensure their housing plan will be constructed as a unique environment complimentary to the surrounding area. More condominium units will be built in both the August Mist and Willowbridge complexes. We're also modernizing the building requirements to meet future energy needs in housing.

Commercially, Phase III of the Springbrook Shopping Center should be finished this year. Merchant's Park at Stratford is growing. The Old Town area is about to come into its own right, we may see a surge of development there. Other areas of the Village will also see growth. And we will, for as long as possible, continue to use Industrial Revenue Bonds as a financial tool to attract desirable commercial development.

**Almanac:** You mentioned Old Town. I know that's a very important area to you. What kind of activity will we be seeing there?

**Mayor Tenuto:** We're seeing a lot of activity there right now. Four new buildings and three renovations are under

progress. And because of this development the Village is investigating avenues to acquire a municipal parking lot as defined in the Old Town Plan. Old Town is the very core of this Village, it gave us a unique character not often found in the suburbs. If this area can be encouraged to thrive it will contribute healthy factors to all the rest of our development. Integrity-wise we cannot turn our backs on the older areas and expect a quality return from the new.

**Almanac:** Aesthetics is another subject you've often discussed. Tell me about future plans along those lines.

**Mayor Tenuto:** We're always conscious of projecting a certain image in Bloomingdale. That's why we're concerned with building design, landscaping, signage — the whole concept of open space in both residential and commercial development. We're also working toward the completion of a totally new and restrictive sign ordinance to incorporate signage into the aesthetics along with the landscaping of commercial enterprises. We must also continue to landscape around Public Works, the treatment plant, street islands, and parkways as funds are available.

**Almanac:** Will there be another phase of the road program?

**Mayor Tenuto:** Yes, again our Engineering Department will prepare a study and prioritize which roads need repair the most. We're also looking to implement a safety improvement program relative to the installation of sidewalks and street lights.

We will also be moving forward with the Springbrook Drainage Improvement which will drain an area from Schick Road and Cardinal Drive northeasterly to the Meacham Forest Preserve. Better drainage will allow for the commercial development of this now vacant property.

**Almanac:** All of these plans sound like good ideas, but let me ask you something. In these days of a de-

pressed economy, energy shortages, cutbacks in both Federal and State financial aid, you're talking about road programs, landscaping, sidewalks, street lights, etc. Do you honestly believe you are being realistic about these goals?

**Mayor Tenuto:** I've only mentioned those I believe to be realistic. We are working against several negatives as you've brought out, but our hands are not tied. The Finance Committee has been directed to formulate and create a Capital Improvements Fund through which we can set aside funds yearly to ensure these various programs will be completed. We will also maintain a high level of service to the community. What we can't attain immediately is still possible if our planning is solid.

**Almanac:** I think the residents also feel these are important and will be very interested in hearing about the Finance Commission's recommendation for the Fund. One last question, do you see the Village expanding beyond its present boundaries?

**Mayor Tenuto:** In all likelihood, Bloomingdale will eventually expand. This new Village Board will undertake a Comprehensive Planning Study this year to examine more closely the areas which might afford potential growth in a responsible manner. We will also be expanding our staff where appropriate to maintain an affordable level of services.

Before we conclude this interview, there are a number of people I want to publicly acknowledge. I'd like to give special recognition to the Board of Trustees and the Village Clerk for their diligence, dedication, and positive problem-solving abilities in accomplishing our 1981 goals. I also extend sincere appreciation to our professional Village staff for rendering a high level of service to the people of our Village. Last, but certainly not least, a sincere thank you to the many volunteers who make up the various Commissions within

the Village. These are the people who bring together much of the research and background work to the Village Board.

Perhaps our most valuable asset is still the continuing flow of effort from the various civic, school, park, and church groups. Their achievements were numerous during this past year. The people involved have provided the foundation of caring and responsibility that makes Bloomingdale the very special Village it is.

Again, on behalf of the local Village government, I am welcoming the interest, concern, and pride of all those residing in the Village. The input is appreciated and reflected in maintaining our rate of progress.

## GRANT FOR LIBRARY

Secretary of State, Jim Edgar, recently approved a \$6,051.22 state "Per Capita Grant" to the Bloomingtondale Public Library. Per Capita Grants are recommended and supported by the Illinois Library Association, and provide direct grants to public libraries that meet application criteria. The grant represents 47.9¢ per person for the population of Bloomingtondale, based on the 1980 Federal Census.

The Bloomingtondale Public Library Board of Directors has earmarked the grant for records, cassettes, and other audio-visual items. These materials will be available to patrons in the new Bloomingtondale Public Library, which is scheduled to be completed this summer.

## Resident Indian Chief

Chief Illiniwek, the mascot (person who brings luck by his presence) of the University of Illinois, is a resident of Bloomington. His name is Scott Christensen, son of Mr. and Mrs. Flemming Christensen.

Chief Illiniwek, representing the complete man - mentally, physically and spiritually - was originated by Lester Leutwiler, the first Chief, in 1926. Mr. Leutwiler also introduced the extensive ritual dance that evolved from an original Sioux Indian war dance. Scott, as the reigning Chief, performs this very rigorous dance routine at halftimes during all U of I home football and basketball games. Scott also makes public appearances around the university, but to be in full dress he must be with the band, of which he is a member. This past fall Scott was proud to perform with the band at Soldier's Field during halftime.



Chief Illiniwek's "full dress" is a beautiful authentic Indian costume. He has a full feather headdress, fringed suede pants and shirt. Individually hand-sewn beads, sewn on by an Indian woman from a reservation in Minnesota, covers the entire costume. The costume is valued between \$2,000.00 to \$3,000.00 and unfortunately, due to ten years of very strenuous use, it needs to be replaced. The Band Association is attempting to raise funds and Scott is speaking as Chief Illiniwek at group gatherings for a small fee, as his way of trying to offset the cost of replacing the costume.

Holding the position of Chief Illiniwek for three years, Scott will be the only Chief in 56 years to acquire the title for that length of time. In the past the Chiefs were Sophomores or Juniors. Scott, however, was a Freshman when he received this prestigious honor. Only one of Scott's 22 predecessors was a woman; Princess Illiniwek reigned in 1945 when all the men were at war. Women do, however, continually try out for the position. Scott had to compete against one woman and 25 men in April, 1981. The reigning Chief last April held training sessions for all competitors to teach them the dance steps and war dance movements. Scott feels his background in track, basketball, soccer and football had to be beneficial in his being chosen. The coordination and agility used in sports is shown time and time again throughout the routine of Scott's dance.

Scott is a graduate of Glenbard North High School and was one of the recipients of the Bloomington Women's Club Scholarship. Scott's future goals are an MBA in Business, then on to law school.

Say hello to Scott if you are at a U of I game. You can't miss him, he is the replica of a Sioux Indian, standing very tall and proud... and don't forget to tell him you're from Bloomington!

## GOLD MEDALS

At the winsome age of three Christina Ceppi took her first plunge in the YMCA's Red Cross Tot Swim Program. Christina loved swimming and was encouraged by her parents, both avid swimmers, to continue in various swim programs. In the summer of her seventh year, a lifeguard at the Bloomingdale Pool became aware of Christina's great strength and natural swimming ability. He suggested to her parents she join the swim team. She excitedly did and proceeded to swim very well in all the competitions. It wasn't long until she moved into the tougher competitions and ultimately joined the B.R. Ryal team at Glen Ellyn YMCA which she represents today, seven years later.

Christina's latest and most valued victories to date are her gold medals. She placed Fourth in the 500 meter free style and Fifth in the 200 meter free style at the Illinois State High School Championship Finals last November. Most of her competition in the finals were Juniors and Christina was one of only four Freshmen to receive gold medals in the entire competition.



This young athlete begins each day at 4:30 AM by lifting weights two mornings a week at the College of DuPage and swimming the other three at Wheaton College. Quickly she returns home to get ready for classes at Driscoll High School in Addison where she is a freshman. She comes home from school at 2:00 PM and immediately begins

homework since she must leave at 5:00 PM for Illinois Benedictine College in Lisle for two to three hours of swimming EVERY evening. On Wednesday she must leave home before 5:00 in order to lift weights an hour prior to swimming. Christina will, on occasion, have a free Sunday (if there isn't a swim meet) when she enjoys cooking and just plain relaxing. Checking her calendar, however, Christina realized she doesn't have a free day until April!!



Anxiety is the emotion our busy girl feels the most lately as she awaits official word on her qualifying for the YMCA Nationals to be held at the Swimmers Hall of Fame in Fort Lauderdale, Florida mid-April. The coaches have already informed all possible qualifiers that there will be NO SUNNING on those beautiful Florida beaches because they can't take a chance on getting a severe sunburn. That certainly says a great deal for true devotion to competition.

Christina and her parents are very hopeful for a swimming scholarship to one of the excellent colleges offering opportunities for the swimmer. California, Florida, Indiana and Tennessee boast having some of the best in their states.

The dedication required to be a gold medalist is incredible, for the athlete as well as the family. To excel in anything you must practice, practice and practice more. With that practice comes many sacrifices for the entire family. And this year Christina's sister Marisa began competing in gymnastics after six years of intensive swimming. This will only

increase the dedication required from everyone.

Christina does feel that she misses a lot in after-school and weekend activities and sometimes she gets down. Her parents, however, have always given her the choice — to swim or not to swim. Christina has chosen, with only a few fleeting moments of doubt, TO SWIM.

The Ceppi family, from attending many practice sessions and competitions, has developed a social life acquiring many new friends and experiences, while setting numerous ideals and goals for themselves. Of course, a few disappointments have been tossed in that make life more challenging. 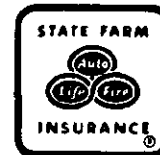

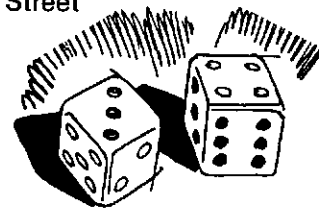

# DISTRICT 13 NEWS

by Brandt G. Crocker, Superintendent School District #13

While students and teachers were on vacation, a great deal was accomplished in the district. All the buildings were cleaned and spruced up. At Westfield, steel reinforcements were added to the roof structure, making it more stable, and for the first time in several years all ceilings are in place throughout the building.

Here at the district office, the time was used for planning and setting up dates for the remainder of the school year. Of special significance are the plans for in-service teacher training.

Some people think that teachers never go to school again after college. Not so. Our in-service (teacher training) program takes into account the detailed assessment we made during the summer of needs of individual teachers in our district. This assessment, coupled with changing needs of the district, sets the tone for our workshop. Four full days,

plus half-days as needed are built into the calendar for this purpose.

This year's program has focused on stress, motivation, responsibility education (helping students be more responsible, being more effective as teachers) and better communication.

Many of our teachers are attending regional seminars on working with gifted students in areas of mathematics, critical thinking, composition, primary education, and the Great Books Program.

Our administrative reorganization has also been completed, with Larry Erickson, now full-time in the district office as Assistant Superintendent of Curriculum, Personnel, and Special Services; Charles Swangren as Principal at Westfield and Michael Pedersen Principal at Central. Mrs. Sally Pryor, formerly teacher and unit leader at Central has been appointed Interim Assistant Principal at DuJardin.

The sale of working cash bonds has enabled us to create a fund of money which earns interest to be used for our ongoing expenses. We were fortunate in being able to sell them at an interest rate of 10.99% for six years, which was very favorable. The bonds provide us with \$60,000 - \$80,000 of additional income each year, depending on the interest rates. The rate of interest on our investment funds last year was over 16%, and we anticipate it will average well in excess of 15% this year. This fund will enable us to keep your tax rate more stable.

In view of the weather, I would like to mention that our calendar, which calls for school to end on June 14, allows for five emergency closing days. Should these days not be used, school will close earlier in June. If more than five are used, they will be made up during Spring vacation.

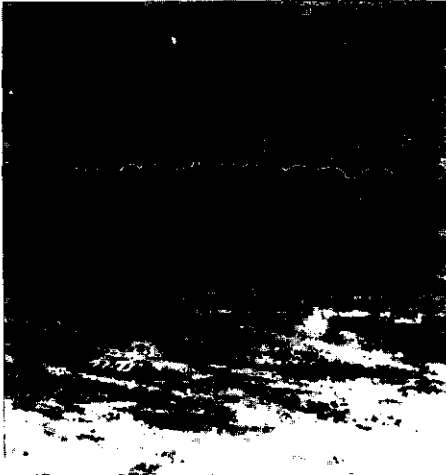

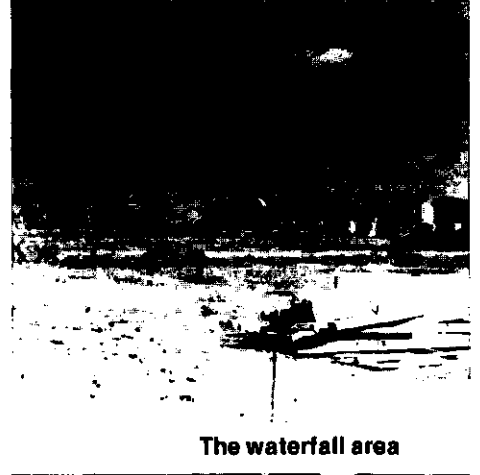

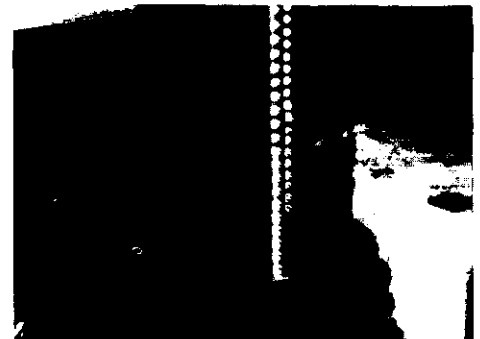
