NOTICE

A concentration of barium in the drinking water of the Village of Bloomingdale presently exceeds the 1.0 mg/1 allowable concentration set by the Illinois Environmental Protection Agency. The Village, on April 29, 1982, received from the Illinois Pollution Control Board, a Variance from the barium standards which is valid until January 1, 1984. The average content of barium in water produced by Well No. 8, is 2.8 mg/1. There is no evidence that this concentration presents a threat to the health of water consumers.

Bloomingdale Continues to "Grow With Pride"

The Village continues to grow with the annexation of territory today and plans for its future growth with preannexation agreements. The property just annexed to the Village is on the south side of Army Trail Road at the intersection of Gary Avenue. On this site will be constructed a Speedway Gas Station, with the remainder of the property to be developed at a later date.

Another annexation just completed is between the Village and Saint Andrew's Ukrainian Orthodox Church. The site is 14.0 acres located on Army Trail Road just east of Glen Ellyn Road. The Church plans to construct a church for five-hundred (500) worshipers, a multi-story structure for senior citizens, and recreational areas. The Ukrainian Church to be constructed in Bloomingdale is one (1) of only a few in the Chicago Metropolitan area and will be a welcome addition to our community.

Looking forward to the future, the Village Board has approved a preannexation agreement with the Italian American Sports Hall of Fame. The Village will, when appropriate, be supplying the IASH+ with sanitary sewer and water, to be extended from the Village boundary at Gien Ellyn Road at no cost to Village residents; and, once the property becomes contigious, will become part of the Village. The property is located at the southwest corner of Lake Street and Medinah Road and occupies approximately eighteen (18) acres. The IASHF site will be developed initially with sport fields for baseball, football, and soccer and later with a fieldhouse and museum housing memorabilia from Italian/ American sports figures. The addition of the internationally recognized IASHF is a great asset to the Village.



TIME CAPSULE

A Time Capsule Committee has been formed by Mayor Tenuto to handle another phase of our Sesquicentennial Celebration. Meeting dates and times have not yet been set, but certain preliminary steps have been taken. Representatives of local organizations will be participating.

Ideas as to what items should be placed in the Time Capsule have been requested through local newspaper articles and letters to the local school districts. The deadline for submission of all suggestions has been set for July 4, 1983. Those selected will be notified in late August. All items selected by the Committee will be placed in the Time Capsule during the opening ceremonies of this year's Septemberfest on Sunday, September 11, 1983 at approximately 11:00 a.m. This capsule will then be sealed and buried in Founder's Park, not to be opened again until the year 2033.


THE MAYOR REPORTS: PROPERTY TAXES — 1983 Village/Library

The property tax bills received recently in Bloomingdale reflect a *decrease* in the Village/Library tax rate from \$.7894 to \$.7442; which also resulted in a decrease in the dollars paid to the Village by about \$3.00 to \$7.00 for a home in Bloomingdale. Unfortunately, other increases on the tax bill caused the total tax bill to increase.


We take pride in the further decrease for Village/Library portion of the property tax. We have projected that next year's taxes for the Village/Library will be decreased further by an approximate amount greater than this year's decrease.

Although the Library and Village are separate and independent for the determination of their respective budgets and tax levies; both are combined on your property tax bill, in one total.


The 1982 Village tax rate would have increased \$.3420 if it were not for the Village Board's abatement (reduction) of \$462,452.00 in property taxes from your tax bill.




Typical Tax Bill Breakdown




Since 1979, the Village Board has abated taxes amounting to \$96,500.00 payable in 1979; \$98,700.00 payable in 1980; \$99,800.00 payable in 1981; \$138,000.00 payable in 1982; and the amount stated above of \$462,452.00 payable in 1983. We intend to continue to implement fiscal policies that will further decrease the burden on local property taxes.



The tax rate of .4789 for the Village only is one of the lowest in DuPage County; and comprises only 6.5% of your total property tax bill. This compares favorably with other taxing bodies shown on the tax bill. (See Circle Graph on "Typical Tax Bill Breakdown").





Sewer & Water Expenditures

LAKE MICHIGAN WATER

On February 28, 1983, the Bloomingdate Village Board agreed to continue in the effort to bring Lake Michigan Water to DuPage County, along with twenty-one (21) other Du-Page County municipalities in the DuPage Water Commission.

Bloomingdale and DuPage County depend on groundwater as our only potable water service for residents. business, and industry; and that supply is gradually being depleted. In 1980, the 650,000 DuPage County residents, along with business and industry, used nearly eighty (80) million gallons of groundwater per day compared to about fifty (50) million gallons per day that can be pumped without depleting the natural supply. This means that the water used by 40% of the County population is not being replaced by natural means. The present daily demand for water is projected to increase to about one-hundred and thirty (130) million gallons per day within the next forty (40) years, an increase of about 60%. The increased demand for water in the future will only accelerate the depletion problem.

Over the past twenty (20) years, water supply planners and engineers have considered numerous alternatives to sustain the delivery of good quality water to DuPage residents. Their conclusion is that Lake Michigan is the most costeffective, reliable, and best quality water available.

The need for good quality water has been recognized by many neighboring communities outside DuPage County, and several other commissions have been formed. Arlington Heights, Palatine, Buffalo Grove, and Wheeling, through the Northwest Water Commission, are currently constructing a Lake Water pipeline. Just north of us, Schaumburg and Hanover Park are part of the Venture Group which is currently obtaining easements for a Lake Water pipeline. There are other communities that have recently made plans to utilize Lake Water to replace their own depleted groundwater supplies and have passed local referendums to approve the financing of these projects.

As can be seen, there is growing concern all around us to water quality and quantity that can be supplied. Water is one of our most precious commodities, and a long-term, viable solution to this problem is of the utmost need to us as residents to insure future supply.

The cost of constructing a pipeline and distribution system is currently estimated at \$310,000,000.00. Costs attributable to the Village of Bloomingdale as our share is approximately \$9,000,000.00.

We are currently working on the most effective and equitable financing method to pay debt service on the proposed bonds. It appears that bonds supported by an increase in Sales Taxes would be the least expensive and the most equitable. Other methods of debt repayment resources considered are property taxes, user fees, and utility taxes.

FALL TREE PLANTING PROGRAM

The Village Board has provided up to \$10,000.00 of expenditures to fund this year's Parkway Tree Program. As done last year, the Village will share in 50% of the cost, with the property owners paying the other half.

The following are details on the program:

- Trees will be furnished and planted during the fall by a contractor hired by the Village.
- The program is for parkway trees only, not for private property. In areas without curbs or sidewalks, the trees will be planted about 15 feet from the street.
- 3. Trees will be guaranteed for one year. Care instructions will be furnished.
- 4. Some locations may not be eligible based on safety reasons.
- 5. A limit of 2 trees per parcel frontage is standard. Corner lots may have up to 4 total.
- 6. Requests will be handled based on the date received.
- 7. The program also will be available to other public jurisdictions and commercial properties, with residential areas having first priority, and commercial the lowest priority.
- 8. The total cost of each tree is *estimated* to be \$80.00 or \$90.00, so the property owners share should be \$40 · \$45.00.

SERVE AND PROTECT

The Bloomingdale Police Department has been especially busy lately with some extra programs to benefit residents. We wanted to both inform residents of these and to gratefully acknowledge their hard work.

In conjunction with our local banking institutions - American Heritage, Bloomingdale State, West Suburban of Stratford, Chicago Federal and Talman Home - the Police Department sponsored the annual excursion to Wrigley Field on May 20 for the Winnebago, Central and DuJardin safety patrols.

A presentation on bicycle safety was given to all grades at Winnebago School on May 25. The Department also conducted bicycle registration and safety inspection at the school for the students, parents and preschoolers. A total of 136 bikes were registered.

For the past two months the Bloomingdale Police Department has been involved in a program of fingerprinting children of all ages. All elementary and junior high schools in Bloomingdale were visited and parents given the opportunity to have their school children and preschoolers fingerprinted.

The records, which are given to parents for safekeeping, are valuable for identification should a child ever become lost, run away from home, or otherwise separated from his parents. The Police Department would like to especially thank Joe and Sam Ensalaco of Print Master in Circle Center for providing the printing of all forms needed for this program. Police will continue to fingerprint children at the station, but request that parents set up an appointment to do so.

Congratulations to our Police Chief Patrick J. McMahon for his recent election to the position of President of the DuPage County Chiefs of Police Association. McMahon just finished a term of one and a half years as the Association's Secretary. He will be sworn in at Medinah Country Club on June 5, 1983.

The Police Department's annual Bicycle Auction will take place on Saturday, June 25, 1983 at the Village Hall beginning at 10 A.M. Items for auction will be on display outside from 8 - 10 A.M. that morning.

STREET REPAIRS

During the Budget review process, the Engineering and Public Works Department prepared a list of Village streets which are in need of repairs and resurfacing. Based upon the list, which was prepared on a priority basis, the Village Board has made available this year approximately \$300,000.00 for the program.

Many of these streets will be prepared first by our own forces, prior to resurfacing by an outside paving contractor in an effort to reduce costs. DISTRICT 13 NEWS

by Karen Gerovac, Board of Education President

(In many school districts, the President of the Board of Education presents an end-of-the-year report. Your Board is taking the opportunity to present this informal report in this column.)

This is a logical time to think about a few of the past year's accomplishments and to think about what the future holds for our students. One of the most important curriculum areas addressed this year was implementation of the new reading program. A recent extensive evaluation of this program has caused the Board to be very pleased with the results. Three years ago the Board launched a program to conserve energy in the schools. I am happy to report that the Illinois Department of Energy and Natural Resources has awarded our district the Energy Management Award for 1982. This is particularly significant because 1982 included one of the coldest winters in our area's history. An earlier column detailed some of the savings realized in our utility bills.

Certainly, however, our economic circumstances are causing us to look at many areas of cost. The Board has already approved a series of cuts in non-personnel areas and continues to study the possibility of further cuts in these areas.

Looking toward the future, we want to give the incoming 117 kindergarten students every educational opportunity the 158 we just graduated have had. With the present projected deficit in our Education Fund (70% of our entire budget) this year, it will not be easy. When the books are closed on the 1982-83 school year, we anticipate that our income will be \$175,000 less than our expenditures. Because of the uncertainty of what the state will provide next year we are not generally optimistic. In fact, our present estimate is that we will receive \$490,000 in general state aid rather than the \$620,000 which we received this year.

In an effort to recover some of your tax money used to repair builder defects in Westfield School, we are cooperating in a lawsuit filed by the state Capital Development Board to recover this money.

Because of the financial crunch, we thought we would have to delay putting micro-computers into our schools. But our volunteers have come forth, with DuJardin and Central Parent-Teacher Organizations, and Westfield's Student-Parent-Teacher Organization pledging \$12,000 to purchase computers.


We are preparing a slide show that will give you an overview of the district's education program and our current financial status. This presentation will be available for community groups by September. We welcome the opportunity of presenting it to you.


