

# 12th Annual Septemberfest

Due to the fact that we go to press a month before Septemberfest, some plans are not finalized. Watch local papers for further information.

COME ONE, COME ALL to the 12th Annual Septemberfest on September 9 (rain date September 16) from 11:00 A.M. to 6:00 P.M. in Old Town (Lake Street and Bloomingdale Rd.) The official opening ceremony will begin at 12 noon on the stage located on Franklin Street. Part of this ceremony will be the crowning of the Bloomingdale Septemberfest Queen.

Once again the annual end-of-thesummer celebration will include numerous booths sponsored by local organizations, food, games, entertainment and antiques. Crafters will be back again this year located on Third Street. (Applications for these craftsmen will be accepted only until August 21. Call Vi Morrisroe, Septemberfest Chairman at 980-7723 for details.)

New to Septemberfest this year will be Chuckles to Reign clown troupe. They will "work" the crowd, as well as having a booth to put clown makeup on the children.

Some favorites are returning for the festivities: the Moonwalk for children, sponsored by Incarnation Church; the Dunk Tank sponsored by the Knights of Columbus of St. Isidore; a show by the Bloomingdale



Park District gymnastic team "The Beamers." The Bloomingdale Public Library will be selling books and the Garden Club will have dried flowers for sale. In addition, the Park District Museum will be open featuring a model train exhibit.

Once again the Bloomingdale Women's Club will be sponsoring its 12th annual Festival of Arts featuring both fine arts and crafts in the Bloomingdale State Bank parking lot. (See separate article for details).

Have you noticed lately, more of your conversations interrupted, television programs drowned out, and sleep invaded by the sounds of planes roaring overhead?

Granted, summertime means open windows and time spent out-ofdoors, so the noise from air traffic is bound to be more evident. However, the increased traffic and noise over Bloomingdale is due largely to some changes in routing for arrivals and departures at O'Hare Airport for nighttime hours.

From January 1 to April 30, 1984 the Federal Aviation Administration conducted a nighttime noise abatement test which routed all departing planes to the west and northwest during nighttime hours, that is, 10 P.M. to 7 A.M. Only after planes climb to 3500 ft. are they then turned into the direction of their destination. The same routing was implemented for arrivals during these hours. The reason for the re-routing was to move the noise away from heavily populated areas. In essence, this brings planes through Bloomingdale.


# THE MAYOR'S DIRECT LINE "Village Adopts \$6.3 Million Budget"

The Village of Bloomingdale adopted its Fiscal Year 1984-85 Budget which provided forecasted total expenditures of \$6,332,442.00 for all purposes. This amount is allocated as \$4,400,759.00 for Corporate and \$1,931,683.00 for Sewer and Water.

Included in the Budget are provisions for the hiring of two (2) new Police Officers and one (1) Community Service Officer. Eight Police Patrol cars are scheduled for replacement; as well as three (3) trucks for Public Works. Village service levels for such activities as street repairs, snow removal, and policing activities will be maintained or enhanced during this Budget year.

Capital Improvements total 18% of the Budget. Some of the major projects include a Computer System for Police, drainage improvements, tree planting, sidewalk replacements, Bloomingdale Road improvements, Engineering for Schick Road Improvements, reconstruction of several streets in Old Town, and general repairs and overlays for several streets in various parts of the Village. These Capital Improvement projects are funded primarily through Sales Tax receipts and reserve funds of the General Corporate fund.

The diagrams (right) illustrate the Village's major sources of revenues and the major expenditure categories. On the expenditure side, as in the past, police protection and major capital projects are given a very high priority. On the revenue side, the State Sales Tax and User Charges are the largest revenue producers. As Stratford Square matures, in addition to the increase in the development that surrounds it and other commercial growth; sales tax revenue will continue to grow which will allow the Village to operate at the same level while relying less upon property tax revenues. Property taxes presently make up only 11¢ of every dollar of Village revenue.

## **PLANE NOISY**

On May 31 the FAA tentatively approved Chicago's Environmental Impact Statement for the city's proposed 1984-85 Phase II O'Hare Airport Master Plan for the expansion of the airport.

The plans call for the extension of an east-west runway to accommodate cargo planes, which are louder than passenger planes, taking off at night. This runway will send planes directly over Bloomingdale. Other plans include extension of a northwest/southwest runway, construction of a new terminal and general aviation and cargo facilities.

The Bloomingdale Village Board, along with 14 other DuPage and Cook County communities, have authorized lawyers to file suit and seek other legal relief to prevent and mitigate the adverse effects stemming from the proposed expansion. All 14 communities are members of the Suburban O'Hare Commission and coordination and supervision of the law suit will be carried out through the Commission.

At this point the Noise Abatement Office is under the impression there is no noise problem in Bloomingdale as it has received so few complaint calls. In conjunction with the suit being filed, citizens are encouraged to call in complaints about excessive and/or continuous noise from planes overhead. The 24-hour hotline number is 686-2377.

Unless the Noise Abatement Office becomes aware of the problem in Bloomingdale, there is absolutely no doubt the situation will become much worse.

### MOSQUITO SPRAYING

Some residents of the Village have expressed concern on the safety of the mosquito spraying program sponsored by the Village and Bloomingdale Township. The spraying is being performed by Clarke Outdoor Spraying Co., Inc. of Roselle who is under contract by the Village and Township. Clarke has been performing this work in the Village limits for more than ten (10) years.

The principal chemical used to abate the mosquitoes is Dursban. Dursban is a very strong pesticide, but not harmful to plants, animals, or humans at the level of strength it is applied in the Village. Extensive testing of the effect of the chemical on different plant and animal groups has been performed by the manufacturer, Dow Chemical U.S.A. of Midland, Michigan. These tests did not result in any injurious conditions to plants, animals or humans. Tests by the United States Public Health Service performed in 1966 through 1968 also demonstrated that applications of Dursban were not harmful to humans in any way.

### MAINTENANCE CODE

Recognizing the need for adequate minimum requirements for existing structures, residential and non-residential in the Village of Bloomingdale, the Village President and Board of Trustees adopted the 1981 BOCA Basic Property Maintenance Code on May 30, 1984.

The Code is intended to establish the minimum acceptable standards for the maintenance and repair of existing buildings, structures, premises and facilities to protect health, safety and general welfare.

The need for the Property Maintenance Code in our community has become increasingly important as our Village grows and gets older.

Copies of the new 1981 BOCA Basic Property Maintenance Code can be viewed at the Building and Zoning Department Village Hall Offices.

The new program will enable homeowners and apartment dwellers to request inspection by a Building Department Official of existing structures, residential and non-residential.





### QUEEN STEPS DOWN





### LIBRARY FINES TO INCREASE







# POPS CONCERT





# SIDEWALK REPAIR PROGRAM

As a part of the budget process, the Village Board has allocated \$6,000.00 this year for a 50-50 cost sharing program for the replacement of deteriorated public sidewalks. Following are the guidelines for the program:

- 1. Private walks and drive aprons are not eligible for cost sharing.
- 2. Sections of public walk which have settled due to an underground utility will be repaired at Village expense.
- 3. For corner lots, the crosswalk portions and the sideyard walks will be repaired at Village expense.
- 4. Residents are asked to telephone the Public Works Department at 893-7000 Ext. 33 with their request, specifying the location of the walk needing replacement.
- 5. The Village staff will inspect the walk and will inform the resident as to the status.
- 6. Depending on the volume of requests, the Village may let a contract for the work, during this coming fall.
- 7. Preliminary cost estimates are \$1.60 for each square foot at the 50% level; with contractor's bid prices to govern.
- 8. Further information can be obtained from the Public Works Department at the Village Hall.
