## "Enhancing Bloomingdale's Future" Mayor Sam Tenuto Reports

For the Village of Bloomingdale, the impact of our accomplishments in 1984, most notably the successful annexation of 134 ± acres along the Lake Street Corridor, will definitely have a positive financial long-range effect on the future development of our community. It is also a year that, in review, we can fully appreciate for the challenge, opportunities, and progress it realized.

#### Annexations

In 1984, we saw the positive results of our solid land planning strategies by annexing the following properties into our Village.

- The Carl Bauer parcel (Curtis Gravel Co.) on Lake Street was annexed on April 9, 1984. This 74-acre parcel has been the subject of much discussion and negotiation for several years. This parcel is strategic in that the 25-acre frontage has high potential for retail uses, generating considerable Sales Tax revenues.
- 2. The old Adventureland parcel of 42 acres, owned by Northwestern Mutual Life Insurance Company, was annexed on June 4, 1984. This parcel will serve as the eastern boundary of the Village; and it also holds great potential for retail/office uses generating Sales Tax revenues to the Village.
- 3. The Italian American Sports Hall of Fame property was annexed on July 23, 1984. This 18 ± acre parcel will be the home of the Italian American Sports Hall of Fame as well as serve as exhibition and training location for sports stars and area youngsters alike. The entire complex is estimated to cost about \$25,000,000.00 and will take several years to complete.


Finally, two (2) additional parcels of land which will add substantially to our Village boundaries and Sales Tax revenues are currently under consideration for annexation in 1985.

#### Lake Michigan Water Project

Although 1983 saw culmination of four (4) years work by this Village and the DuPage Water Commission to bring Lake Michigan Water to DuPage County, 1984 saw a complete reversal because of actions by the State Legislative leadership.

The State passed a law which effectively:

- 1. Abolished the DuPage Water Commission, a *voluntary* group composed of twenty-two (22) member Municipalities, but open to all the other twelve (12) DuPage Municipalities and the County itself.
- 2. Established a new DuPage County Water Commission, controlled by the Chairman of the DuPage County Board.
- 3. Caused the *old* Commission to cancel and abandon the pending sale of \$16,000.00 in Bonds purchased by Merrill Lynch because the member Municipalities did not want an obligation to repay Bonds for a project in which they had no direct control.
- 4. Caused a delay in the Water pipeline project, estimated by the new Commission at three (3) years, which could mean an increase in project costs in the range of \$100,000,000.00 or more!

Fifteen (15) DuPage Municipalities have banded together and contributed \$5,000.00 each for the purpose of litigating this entire Statute in Court. Twelve (12) of these Municipalities are named in the law suit which charges many provisions of the Statute as unconstitutional, as well as documents other substantial failures.

To our minds it is simply incredible that a State law was passed to give subjective control of the Water pipeline project to County (and State) officials, when it was known it would cost the taxpayers additional millions of dollars because of delays.

The County has now requested the Village to advance funds to construct a portion of the pipeline that would be under Bloomingdale Road, to replace the monies lost when the Water Commission bonds were cancelled. The new County controlled Water Commission has no money, but has authority to borrow unlimited funds from the County.

The County "suggests" they may hold up or postpone the reconstruction of Bloomingdale Road in 1985, unless money is "loaned" to the Water Commission for the pipeline.

The Village has refused to loan them money for this purpose because the pipeline serves only Roselle, the County has authority to loan the Water Commission money, and it is a County project, not ours. It would make as much sense for us to loan the Water Commission money, for a project to serve Roselle, as it would to loan money for a project to serve any other Village.

#### **Planning Project Update**

The Village Board, in 1984, made progress in developing a new Comprehensive Plan. The purpose of the plan is to provide the community with comprehensive planning and development policies to be used in guiding future land development. As part of the comprehensive planning process, public hearings will be conducted in order to get residents' input on how they envision future land development in Bloomingdale. Please make an effort to be part of this process. Public hearing notices will be published in the local newspapers.

#### **Cable TV Update**

Cable TV in Bloomingdale is at a point where, as of January 4, 1985, the cable has "passed" 3,381 housing units. Effective December 22, 1984, there were 2,127 actual subscribers or about 54% penetration.

Recently, Dow Jones Cable News was added on Channel 40. There are no immediate MetroVision plans to add more services.

One problem area in Bloomingdale has been the Fairfield Condominium area where MetroVision ran into design problems of the cable network system. Metro-Vision states that the redesign and completion of this area will occur in Spring 1985. Bloomingdale is a member of NORDCAT, a consortium with Roselle, Carol Stream, Itasca, and Wood Dale to provide Cable TV. Our system is in its infancy, and there is a great deal of work to do to start up such services as "local access", "local origination", and increase Cable TV coverage of local events.

NORDCAT has recently hired, effective January 10, 1985, a Cable Coordinator. Catherine Wiater is our Cable Coordinator and will temporarily office in the Roselle Village Hall (980-2000). She will be contacting many of the Community organizations in the next few months and introducing some of the activities available in Cable TV. Miss Wiater will initially be working on a part-time basis, between 20-30 hours per week. She comes to us with good experience levels and qualifications.

Any problems with your Cable TV should be reported, first by telephone, and a follow-up to Miss Wiater in writing. Service levels have not been as high as we would like, and we expect MetroVision to improve. We invite your comments. Remember, Cable TV is primarily an entertainment medium as it is presently constituted nationwide. Like any other entertainment service, it depends on your feedback.

#### O'Hare Field Expansion Update

Since 1982, the Village of Bloomingdale has been a member of the Suburban O'Hare Commission (SOC). SOC is a group of Municipal agencies that have banded together to fight noise and air pollution caused by O'Hare Airport. SOC has been attempting to stop the planned expansion of O'Hare Airport because adequate testing of the impact of increased noise and pollution on suburban communities has not been performed by the City of Chicago, the Federal Aviation Administration Agency or the Federal Environmental Protection Agency. Most of the people to be affected by the increased traffic flow at O'Hare live in DuPage County. DuPage County and its Municipal governments will not benefit from the expansion, while, at the same time, taking on the burden of absorbing more noise and pollution.

During the last year, Village Trustees and Staff members have attended numerous meetings of the O'Hare Advisory Commission and SOC to assure that the interests of the residents of Bloomingdale are heard by representatives of the City of Chicago and the Federal regulatory agencies.

Now that the planned expansion of O'Hare is underway, the members of SOC, not including Bloomingdale, have filed a major lawsuit against the City of Chicago and the Federal regulatory agencies. The Village of Bloomingdale did not elect, at this time, to join the lawsuit, which would cost the Village at least \$25,000.00 over the next two (2) years, because of the interests of Bloomingdale and the other SOC communities were coming into conflict. The Trustees believed that the airport ring communities would support plans to push the noise further west, thus

conflicting with the interests of the Village of Bloomingdale.

The issues of whether to join the lawsuit is still active. The Village has recently received a copy of the SOC lawsuit and is in the process of reviewing it in light of the Village's interest. Meanwhile, noise monitoring stations have been constructed at school locations in the Village. A study is being performed by the City of Chicago through city funds and a Federal grant to monitor airplane noise in the effected suburban communities. The Village will thoroughly review the findings of this study when it is presented in the Summer of 1985.

#### **Police Programs**

#### **Community Relations**

1984, the first full year under new Police Chief Gary J. Schira, saw the Police Department expand their efforts in the area of *Community Relations and Crime Prevention*. Emphasis was placed on the mutual interdependency of the Police Department and the citizenry in preventing crime. Some of the specific accomplishments in this area are as follows:

#### **Neighborhood Crime Watch Program**

Since January the Police Department has held over thirty-six (36) meetings throughout the town regarding the Neighborhood Watch Program, explaining the deterrent effect such a program has on crime. To date, there are four (4) organized Neighborhood Watch Groups in town, consisting of seventy-one (71) active participants. More groups are in the formulative process at this time.

#### **Business Contacts**

In the course of the year, the Police Department held twenty-seven (27) meetings/training seminars with various businesses or business groups in town covering a multitude of topics, e.g., security surveys and recommendations, detecting fraudulent checks and credit cards, shoplifting, etc. A police training program can be customized to each business and the problems encountered.

#### Senior Citizen Groups

Meetings have been held with various Senior Citizen Groups (especially through the Park District and the Township) on subjects ranging from con games to home security. Also, an article from the Police Department appears monthly, targetting the problems pertinent to senior citizens, in the Township newsletter. We recognize that senior citizens are a very viable part of our community with problems somewhat unique to their own group. Thus, we have tailored programs to meet their needs.

#### School and Youth Programs

This year saw the Police Department become much more active in an organized fashion in the presentation of programs in each of the elementary, junior high, and pre-schools in our town. The Police Department takes great care in the planning of these programs, involving the various school leaders, to ensure that specific topics are covered at the appropriate times in the proper manner.

Through the generosity of the Women's Club, Lions Club, Cub Scout Pack 57, and DuJardin School PTO, a Crime Prevention Puppet Program was purchased by the Police Department for use in our youth education. This program has been extremely popular and successful, the Police Department having presented the program sixteen (16) times since September to well over 1.534 youths.

The Police Department was also involved in the fingerprinting of approximately 1,862 children in schools, in Old Town, and at Stratford Square, in concert with child's safety instruction.

#### **Police Records Hours**

The hours for our Police Department Records Section were expanded to include evening and Saturday hours. These expanded hours enhance public accessibility and make for a much more equalized workload.

#### **Liquor Control Ordinance**

The Liquor Control Ordinance has been very carefully revised and updated, recognizing the very serious consequences that result from alcohol abuse and a disregard for liquor laws if proper safeguards are not in place. This new Ordinance should be adopted in early 1985.

#### **Enhanced Communications**

In other areas, 1984 saw the installation of a better radio communication network, which achieved the goal of giving our Department reliable communications with our street personnel at all times, regardless of their locations. This results in higher availability of officers to respond to citizens' calls for service; in the past, some calls could not be dispatched immediately because we could not reach our officers at the time.

#### Computer Network

In 1985 the Police Department will be installing and implementing a new computer network. By linking ourselves to the DuPage County Criminal Justice Information Systems, we are able to ensure better service for the public. Computer-Aided Dispatching will result in improved service and will also enable our Department to adjust our patrol patterns to fit developing crime patterns. The wealth of shared information available through CJIS also means that we will be better equipped to deal with repeat offenders who commit crimes in a number of different Municipalities and have, in the past, evaded a more vigorous prosecution due to lack of centralized information. For example, CJIS will enable us to identify repeat D.U.I. offenders and allow us to inform the Courts of such. CJIS also includes a physical profiling program, where unidentified offenders can be more quickly identified by physical descriptions of known offenders already on file. By sharing information through the CJIS network with other jurisdictions, we may also contribute to better law

enforcement on a wider area basis.

By utilizing the power of our new computer system, we will also be able to engage in a more comprehensive program of crime pattern analysis than was possible in the past and engage in more pro-active patrol strategies designed to put our police officers into areas within our town at times when our officer's presence is most likely to deter identified patterned crime.

#### **Accident Analysis**

In 1985 the Police Department will get much more active in its analysis of traffic accidents and the causative factors involved. Together with our Engineering Department, we have already begun to analyze the accident patterns on Lake Street and Army Trail Road. With further research, we hope to address both enforcement and engineering problems so that travel in Bloomingdale is a safe and quick venture.

#### **Expansion of Neighborhood Watch Program**

One of our Community Relations goals for 1985 is an expansion of our Neighborhood Watch Program. Without question, we need more active participation by residents in this program; and we need to ensure that all neighborhoods in the Village are properly represented. Active Neighborhood Watch Programs in other towns have proven to be successful in reducing burglaries and other crimes in residential areas. This has been documented. More involvement on the part of our residents is needed to make our program a success. If you are interested in joining this program, please contact the Bloomingdale Police Department.

#### **Building and Zoning Activities**

The Village of Bloomingdale continues to realize a steady increase in commercial, office, and housing construction. Total construction cost in 1984 was \$10,945,271.00.

James Krautstrunk, our Director of Building and Zoning, and his Staff worked on the following major projects:

#### **URBAN AREA**

#### 1. STRATFORD SQUARE MALL

Tenant Spaces: Work has been completed on eleven (11) tenant spaces, six (6) of which are new and five (5) are relocations or remodelings. This brings the mall totals from 160, 90% completed in 1983 to 166, 95% occupied for 1984.

MainStreet Store: A 75,000 square foot major department store was started in 1984; and, when completed, it will bring the mall up to five (5) major department stores and will increase the gross square footage for Stratford Square up to 1,475,000 square feet.

#### 2. ASA/OFFICE COMPLEX

The first building (80,000 square feet, four stories high) has been completed, and construction has begun on the second building (100,000 square feet, four stories high with a basement) and a glassed-in atrium (12,000).

square feet) which includes the complex's main entrance and reception area and also an employee health club and dining area.

#### 3. STRATFORD MEDICAL CENTER

The two-story, 25,000 square foot, medical center was completed in 1984.

#### 4. COURTYARD OF BLOOMINGDALE

This new 31,321 square foot shopping center, containing Herman's Sporting Goods and other tenants, was completed in 1984.

#### 5. PIZZA HUT

A new Pizza Hut Restaurant was started and completed on Army Trail Road near Gary Avenue. Because of our concern for aesthetics, the building is of the traditional corporate design; however, the roof and trim color has been toned down from the typical glaring red to a more suitable, pleasant dark brown color.

#### 6. BLOOMINGDALE FASHION CENTER

Located on fourteen (14) acres on the south side of Army Trail Road at Wheaton Road, the new \$13,000,000.00 "Off Price Center", a 157,000 square foot shopping center containing forty (40) stores, anchored by Marshall's and Designer Depot, is under construction and expected to be completed in the Summer of 1985.

#### SPRINGBROOK CENTER

#### 1. CONNIE'S/PORTILLO'S

A brand new concept pizza/hot dog restaurant has been completed and is in operation. The development of Connie's/Portillo's completes the final phase of the Springbrook Shopping Center.

#### **OLD TOWN DISTRICT**

Old Town continues to grow while our community benefits, not only from the Sales Tax revenue generated and increased assessed value, but, more importantly, for having the foresight to save and develop the unique character of Old Bloomingdale.

Last year we saw the renovation of the old DiBendo house located at Third and Franklin into the beautiful "Turn-of-the Century Prairie House" for offices. This building brings the total restored Old Town buildings to twenty-two (22).

Also approved for development was "Evergreen Farms" located at the northwest corner of Maple Avenue and Lake Street. This development will consist of 4,485 square feet of retail sales area and 7,215 square feet of office use.

For 1985, developer plans are currently being reviewed for commercial and office development north of Lake Street.

#### **Public Works and Engineering Programs**

In 1984, Daniel Wennerholm, our Director of Public Works and Engineering, and his Staff completed the following major programs:

#### I. TRANSPORTATION

 Design work began and was 80% complete at year's end for the widening and improvement of Schick Road between the Indian Lakes Resort and Bloomingdale Road. This project will provide a four-lane road, new street lights, and sidewalks. Major funding is being pursued through the FAUS (Federal) program.

The current estimated construction cost is \$878,000.00, of which the Village will pay 30%, or approximately \$300,000.00. The exact schedule for construction has not been established, but it is anticipated to occur in 1985 or 1986.

- 2. Pedestrian access to the Village Hall and Library was enhanced by the construction of a new sidewalk along Bloomingdale Road between Edgewater Drive and the Village Hall. This project cost approximately \$15,000.00. The Village Board is expected to fund the completion of the new sidewalk program from Edgewater Drive to Greenway.
- 3. A major improvement in our Old Town area was planned for 1984. This project involved the improvement of Third Street from Lake Street to Washington, and Franklin Street from Third to Bloomingdale Road. Bids were opened in July; however, the low bid contractor was not able to perform. This project, estimated to cost approximately \$130,000.00, will be held off until the 1985 construction season.
- 4. Work continued on the improvement of Bloomingdale/ Roselle Road between Franklin Street and the Milwaukee Road tracks in Roselle. Design work is completed, and the acquisition of property is now continuing. The Village of Bloomingdale continues to act as Lead Agency in the administration of our agreement with Roselle and DuPage County.
- 5. The construction of Springfield Drive (Special Assessment No. 7) was virtually completed in 1984. Work on the street lights and traffic signals is expected to be completed in late January 1985, and the road will be officially opened at that time. The final construction cost will be approximately \$1,230,000.00.
- 6. Upon completion of a professional traffic study, the Village posted one-way signage on Franklin Street next to the Post Office. Traffic problems were significant at that location with the two-way pattern.
- 7. New street lights were installed late in the year by Commonwealth Edison at the following locations:
  - 1. Tee Lane & Pleasant Avenue
  - 2. Pleasant and Nordic
  - 3. Euclid and Nordic
  - 4. Schick and Ridge
  - 5. Euclid Avenue and Euclid Court

Arrangements were also made for eleven (11) additional lights in the Lakewoods and Suncrest areas.

#### II. MAINTENANCE OF INFRASTRUCTURE

 Our Street Resurfacing program was again completed this year using in-house staff for the design and contract administration and utilizing our Street Repair crews for the patching. The following streets were completed:

Arbor Lane from Byron to Douglas
Douglas Drive from Arbor to Bedford
Byron Avenue from Bedford to Fremont
Hawthorne Drive from Euclid to Juniper
Juniper Lane from Hawthorne to Circle
Ironwood Drive from Euclid to Glen Ellyn
Fairfield Way from E. Millford to 168 Fairfield Way
Schick Road from Ridge to ½ blk. east of Fairfield
West Road from Schick to Franklin
Cardinal Drive from Schick to 272 Cardinal
Sterling Lane from Edgewater to Royce

The Village paid approximately \$151,500.00 for contract resurfacing, plus approximately \$7,000.00 for material used by our own crews. Additional repair work was performed in other areas by our own crews.

- 2. The stormwater retention lake in the Fairfield Subdivision had, over the past six (6) years, collected sediment from upstream areas. This sediment had collected to the extent that an island was formed, and the Village arranged to have this sediment removed. Cooperation from the neighboring residents certainly assisted greatly in this process.
- 3. A new Sidewalk Repair Program was implemented in 1984. Actual construction was delayed until 1985 due to contractor problems. The Village had budgeted \$6,000.00 for this purpose; but, with funds remaining from road repairs, the estimated expenditure was increased to about \$9,000.00. Several residents and property owners are participating in this program.
- 4. Significant progress was made on the computerized Street Maintenance Management System (PAVER). Field work and office data was collected, using a temporary seasonal employee, and has been entered on the computer. This data will be used to prioritize the Street Repair Program for 1985.

#### III. DRAINAGE IMPROVEMENTS

- A perforated drainage pipe was installed in the Longridge Park/Detention area. This project was performed with funds from the developer and was designed to enhance the future maintenance activities in this area.
- 2. A study was conducted relating to the future maintenance and possible improvements to the cement culvert along Colony Green Drive. This area is experiencing problems with the street curbs and fence maintenance. Further discussions on the various alternative improvements will be held this coming year with the Townhome Association Board members.
- New wooden retaining walls were constructed with our own crews at the head end of the ditch along Fairfield Way, near Circle Park. Erosion had previously washed dirt away, making these repairs necessary.
- 4. Another erosion problem was corrected south of Lakeview Park, behind Pleasant Avenue in North Suncrest. This work involved the installation of a new inlet and pipe and was done by our own crews.

5. A major drainage improvement project, in the Spring-brook watershed (Special Assessment No. 8), was completed in 1984. This project involved the construction of an outfall sewer for the Indian Lakes Resort and a large area of vacant land north of that site to Lake Street. Preliminary design work had been implemented in 1980. The final construction cost was approximately \$670,000.00, with the private properties assessed for about 90% of the project.

#### **IV. AESTHETIC IMPROVEMENTS**

- 1. The Parkway Tree Planting Program, which has been quite successful over the past two (2) years, was enhanced this year by offering front yard trees, also. Trees were ordered by residents, and planting is scheduled for Spring 1985. A total of \$10,000.00 was budgeted, with residents sharing 50%. A total of 145 trees were ordered by residents.
- 2. Fifteen (15) new large Poplar trees were planted at the Wastewater Treatment Plant this Fall in continuation of our enhancements in this area. Also, wooden ties were placed around the trees along Glen Ellyn Road and within the Plant to beautify the area. The chainlink fences around the Wastewater Treatment Plant were painted to help preserve their life and to improve the appearance.
- 3. The Street crews erected a wooden split-rail fence in front of the Public Works Garage.
- 4. With funding provided by Urban Investment and Development Co., the Well No. 8 Pumping Station property on Gary Avenue was enhanced with a number of new trees and shrubs.

#### **ZONING CODES UPDATE**

- 1. Subdivision Regulations are currently being revised and should be completed in 1985.
- Off-Street Parking and Off-Street Loading Ordinance Update, which contains standards and requirements for fostering increased safety and less congestion in our streets, is currently being reviewed by our Village Attorney for adoption by the Village Board in early 1985.
- Planned Unit Development Ordinance Update, which will permit on two (2) acres or more a better quality development while adhering to our Comprehensive Planning Standards, is currently being redrafted and is expected to be adopted by the Village Board in 1985.

#### **Financial Activity**

Reflecting back on 1984, with all of its ups and downs in the prime rate, stock market, and retail sales in general, the Village came through "looking good". Patricia Just, our Finance Director, and her Staff continue to do an outstanding job in handling the financial affairs of the Village.

#### Village Tax Levy

The 1983 Tax Levy, collectible in 1984, reflected the con-

tinuing effort on the part of the Village Board to reduce the Corporate Property tax rate applied to our property. The Village tax rate was reduced from \$.4789 to \$.4345, which means that the dollars paid to the Village itself on a typical single-family home decreased by \$10.00 and more.


We take pride in the further decrease in the Village tax rate. Next year's projected tax rate will be about \$.4000 which will, again, reduce the taxes paid on a typical single-family home by \$10.00 or more.

The 1983 Village tax rate would have increased substantially if it were not for the Village Board's abatement of \$552,897.50 in property taxes from your tax bill.

Since 1979, the Village Board has abated taxes amounting to \$98,700.00 payable in 1980, \$99,800.00 payable in 1981, \$138,000.00 payable in 1982, \$462,452.00 payable in 1983, and \$552,897.50 payable in 1984. For taxes payable in 1985, the Village Board has already abated \$609,885.00 and is expected to abate more in early 1985. This calculates out to about \$105.00 savings on a home assessed at \$25,000.00 if the \$609,885.00 was *not* abated. We intend to continue to implement fiscal policies that will further decrease the burden on local property taxes.

The tax rate of .4345 is one of the lowest in DuPage County, and comprises only 5.6% of your total property tax bill. This compares favorably with other taxing bodies shown on the tax bill.

The decreases in your property taxes over the last several years can be attributable to:

• over 2,741,493 square feet of commercial development since 1979, at a construction cost of \$220,000,000.00.

- sales tax generated from commercial development from \$173,419.00 in 1979 to a forecasted \$2,000,000.00 in 1984.
- sound land planning efforts
- a financial policy of utilizing Sales Tax revenue generated from commercial development to reduce our Village Tax Levy.

The decline in property taxes would even be greater except for the fact that a portion of the Sales Tax revenue generated from Stratford Square goes back to pay Urban for funds advanced to complete our share of Wheaton Road, Schick Road, and Springfield Drive. Once the debt of \$4,143,462.00 is retired in 1993, the Sales Tax will make a most notable dent on our property tax levy.

#### **Closing Statement**

Throughout 1984, Bloomingdale set an example of the benefits to be derived by leaving neither Village growth nor

improvements to chance. Policy and planning set direction, but the credit for gains made is in large part due to the continual efforts of those responsible for day-to-day operations. The Village Staff and Bob Reeves, our Village Administrator, can be proud of their work done this past year. My sincere thanks to our Village Clerk, Board of Trustees, and Commission members for the endless hours and commitment contributed on their part.

Last, but most important, Bloomingdale is excelling as a quality community because of the many caring residents involved within the civic, school, park, and church groups. They render a vital support system, determine local character, and provide the motivation necessary for a high quality of life in Bloomingdale.

Again, on behalf of the local Village government, I welcome the interest and concern of those residing in the Village. Your input is always appreciated.



## DISTRICT 13 NEWS

If you are a School District 13 resident, you can expect a volunteer to visit you between February 13 and 22 to take a special census. They will be counting the number of children who are five years and under not presently attending public school. If you are not at home when the volunteer calls, a card will be left for you to fill in which will be collected at a later time. Should your preschoolers be missed in this census, please call the district office at 893-9590.

The reason for the census is to plan classroom use, staffing and budgeting for the coming few years at Central and DuJardin Schools. A disproportionate number of children have entered Central in the past two years. Since it is the smaller of the two buildings, the district needs to know whether this trend will continue, or whether it is a two-year bubble.

After volunteers have taken the census, and the results have been tallied, the Board of Education will look at the results and develop alternatives, if any seem to be needed. A public hearing will be held at each school building to hear the community's input should changes be recommended. About the end of April, the Board will need to decide what action, if any, needs to be taken. The final budgeting for the coming year will need to be done soon thereafter.

You may be wondering about the additional money the school district has received from the state amnesty program. The money amounts to about \$51,000, which will help keep a reasonably balanced budget for this fiscal year.

Volunteers are still needed for the School District 13 special preschool census. You do not need to be a parent. Interested persons should call Central School, 529-2223 or DuJardin School, 894-9200.

LIONS SAY THANKS

The Mayor and Board of Trustees hosted their annual appreciation dinner in January to thank the many volunteers who make up the various commissions and committees necessary to help the Village Board govern the community.

While all those in attendance were very special guests, one person was singled out and recognized for his outstanding contributions over the years toward making Bloomingdale a safer community.

Fire Chief Lawrence Harvey Koehn retired January 9 after giving just short of 32 years to the Blooming-dale Fire Protection District. Koehn, a 52-year resident, joined the fire department as a volunteer fireman in April 1953. He was promoted to assistant engineer in May 1955, to engineer in May 1958, to captain in May 1960, to assistant chief in May 1962 and to chief in November 1966-all of this while the fire department was still all-volunteer.

On January 1, 1969 Koehn was made the first fulltime employee of the Fire Department. He was appointed fulltime fire chief in April 1973. His accomplishments as chief include establishing a Fire Prevention Bureau in 1973, ambulance service in 1973 and the paramedic service in 1978.

Mayor Tenuto presented the former chief with a plaque expressing gratitude for his many years of service. Koehn commented on his pride in how far the department has come. In reference to growth he mentioned that when he joined the department there was an average of 39 calls a year. Last year they logged well over 2000 calls. He praised the paramedics saying they were the most dedicated you could find.

On his retirement, Koehn commented that while it felt strange, it was really nice to hear a fire engine in the night and be able to roll over and go back to sleep. On January 10 the Bloomingdale Lions Club hosted their second annual appreciation dinner at Glendale Country Club. The event affords the club an opportunity to thank those local businessmen and women and professionals who have consistently and enthusiastically supported Lions' fundraisers with goods, services or funds.





The stop signs on Schick at First were removed and relocated to the Ridge Avenue intersection after a review of the traffic situation. One of the main reasons for the signs was lack of visibility. We recently improved this visibility to the extent we felt necessary so as to prevent accidents. These signs were also impeding traffic flow through the signal at Bloomingdale Road and causing unnecessary delays.

The signals at Army Trail and Skylark are the type known as "fully actuated". In other words, Army Trail Road will remain green unless there are vehicles on Schmale or Skylark which are waiting to cross or enter the intersection. Years ago, before these types of signals were available, flashing lights were used as you suggested. However, the new technology provides for a safer intersection and the flashing light method is no longer used.
