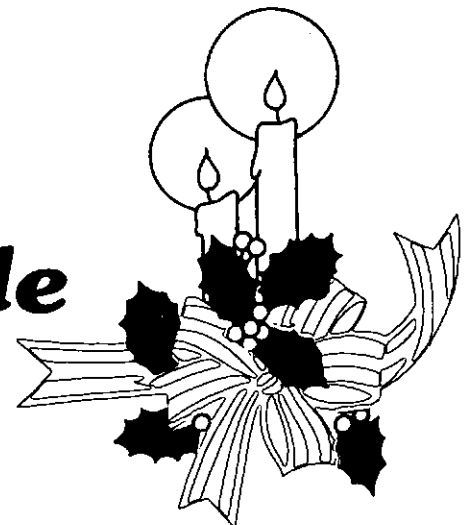
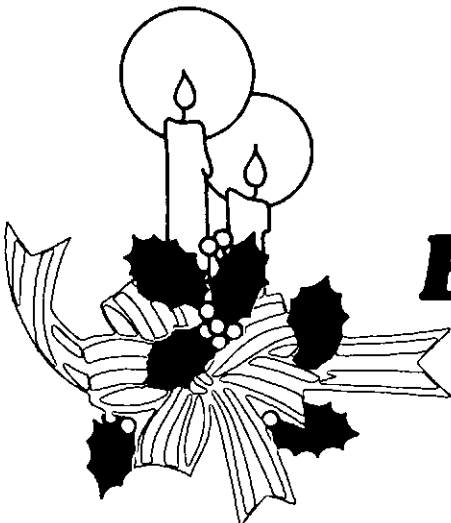

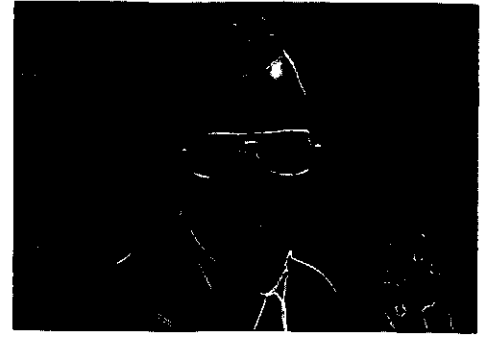

# THE MAYOR'S DIRECT LINE

## "Boom in Residential Growth"



Bloomington has seen a tremendous surge in commercial development within the past few years, starting of course, with the Stratford Square Shopping Mall. We have been experiencing some residential growth, but we are now on the verge of a surge in that area.

Originally, the Stratford Planned Unit Development (PUD) had called for 6500 housing units on the 400+ acres designated residential. Through our endeavors to maintain the character of our community and its quality of life, the number of units was brought down to 2300.

This "down zoning," as it is called, will provide more open space and less congested groups of neighborhoods in the area than had originally been planned. Rather than all multi-family housing, a significant number of single family residences are to be constructed.

On the opposite page you will find a map designating the new development on the horizon. On the north side of Schick Road between Connestoga Estates and Country Club Estates are Heritage at Stratford, Bloomfield Hills and Chateau Lorraine.

Heritage at Stratford is being developed on a 80-acre parcel by Meridian Development Group, Schaumburg. One hundred and ninety single family homes featuring six different elevations ranging in size from 1744 - 2296 sq. ft. will be constructed. Prices start at \$130,000 and go to \$160,000.

Heritage at Stratford has been approved by the Village Board. Currently, streets and utilities are under construction there.

On the east side of Springfield Drive is Bloomfield Hills, a subdivision planned by Hoffman Group, Inc. Schaumburg on a 58-acre parcel. The 191 homes will come in eight different elevations ranging in size from 1790-2650 sq. ft. Prices range from \$133,000 - \$160,000. The project is waiting for the ordinance to be adopted in order to receive the green light.

East of Bloomfield Hills is Chateau Lorraine, a townhome project by Pulte Homes Corp. The 164 townhomes, which will be all brick and cedar, start at \$115,000 and go to \$160,000. They will range in size from 1340-2200 sq. ft. This project has also been approved but no construction has started.

On the south side of Schick Road is what is currently known as Neighborhood "C" which is still on the drawing board. Preliminary sketches of proposals for the 114-acre parcel were recently submitted by Hoffman Group.

Plans included five types of housing:

- 77 single family homes on 11,000 sq. ft. lots, starting at \$160,000.
- 137 single family "cluster" homes of a new concept, starting at \$130,000-\$160,000 and up.
- 313 townhomes
  - Large luxury townhomes, \$115,000 - \$140,000 and up.
  - Smaller townhomes, \$90,000 - \$100,000.

- 200 apartments in two and three-story buildings.

Formal plans for Neighborhood "C" will be submitted to the Plan Commission after the first of the year.

Also planned for the area are two schools, one for District 93 and one for District 13, as well as two park sites. The 37-acre park site located north of Chateau Lorraine is currently being graded. Although specific details are not yet available, this park area should complement Circle Park as the district's second major play area.

In addition to the planned development described so far, Country Club Estates, developed by D.E.M. Enterprises of Bloomington, still has building underway. Among the housing to come are 36 country ranches to be built in three different styles. They will range from 1750 - 2600 sq. ft. and \$133,900 - \$150,000.

Also planned are 65 estate units, 3000 - 3600 sq. ft. at \$174,500 - \$189,000 and three-story single family brownstones with optional elevators. Modeled after the Chicago brownstones, the 3300 sq. ft. homes will start at \$200,000. An eight-story apartment complex with underground parking and a swimming pool rounds out the Country Club Estates development. Monthly rents will range from \$800 to \$1,200.

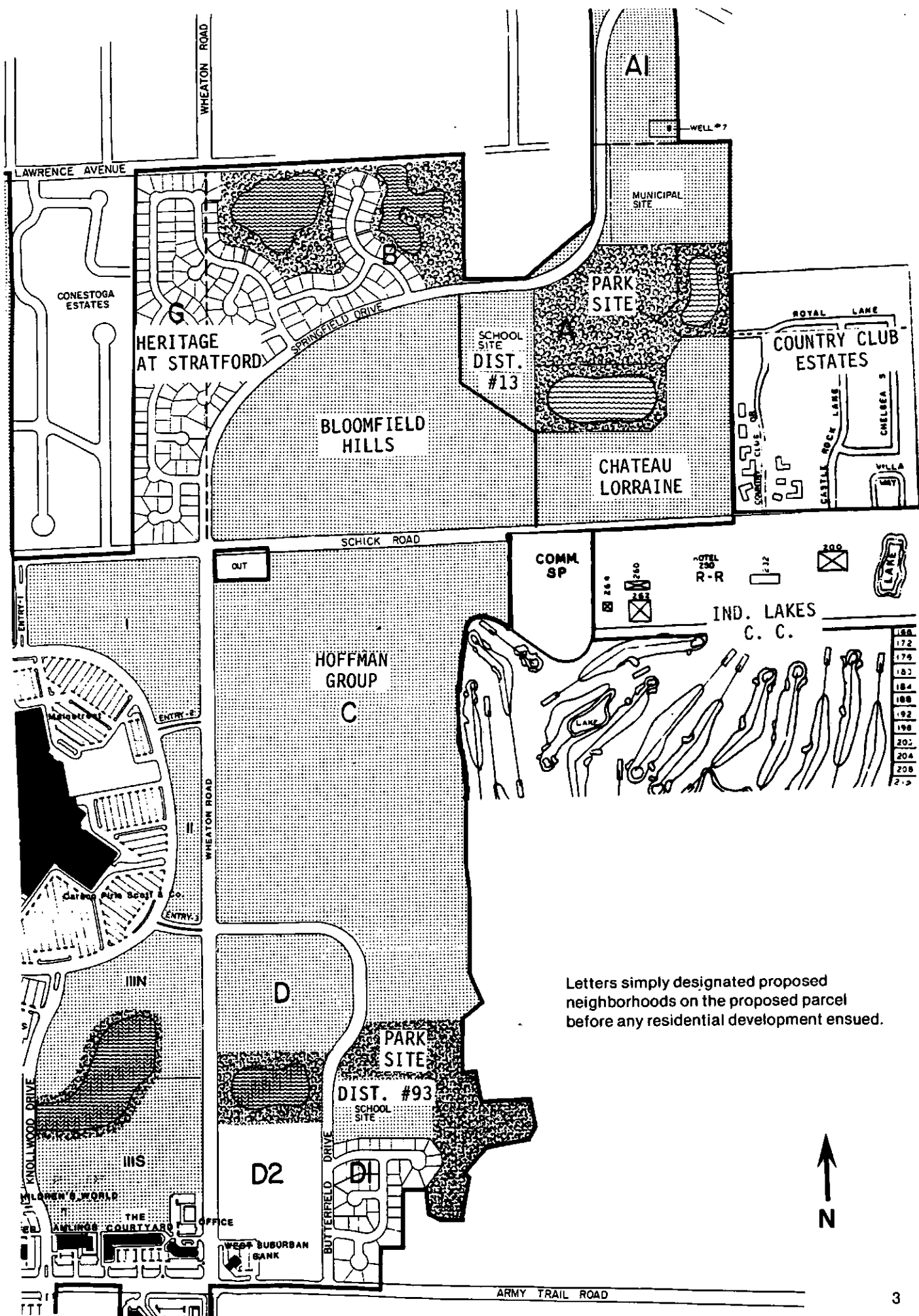
Residential development is also underway on the west side of Bloomington Road (fronting on Bloomington and approx. across from Fairfield) stretching back toward Longridge. It is another development of D.E.M. called "Founder's Pointe" consisting of 51 single family custom homes on individual lots of 10,600 - 19,000 sq. ft. The entire area will be enclosed with a full-time guard on duty. Lots can be purchased starting at \$53,900. Lots and houses start at \$225,000. Thirty-one lots have already been sold.

We believe all of these unique developments will enhance the community and will be in keeping with the character and quality of life we have striven to maintain in Bloomington.

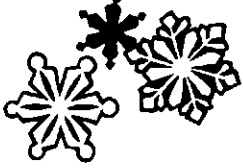

# LIBRARY SEES CHANGE IN ADMINISTRATION

After over seven years of growing with the Bloomingdale Public Library, administrative librarian Gay Nass will be leaving to spend more time with her family. She reflected over the last seven years and discussed some of the milestones she has seen.



"Passing the referendum for a new library building in 1980 with a 4-1 margin was tremendous, especially since two years previous it was voted down. It meant the community was really behind us.

"With Stratford Square opening up the year before, it was like the blossoming of Bloomingdale. Growth was really happening quickly. Watching the library building go up was such an exciting time for the whole community... it was something we were all involved in. Every community group donated or helped out in some way."

Going on-line with circulation on September 3, 1985 was another important step for the library. The date is one Gay will never forget although she wasn't there in the library at the time. She was giving birth to her first child, Amy Elizabeth.

Gay says she is thankful for the years she has spent here. The Bloomingdale Library has provided her with opportunities few librarians experience, such as going through a building project from the referendum on.

She was able to create a personnel manual, to set policies and procedures, to hire a growing staff (from 5 to 18). These experiences were hers because our library is so young.

In looking ahead, she explains she's made a lot of friends, both personal and professional, many of whom she won't come in contact with again. "I'm sorry about losing touch with them, that's the hard part. But I am leaving with a sense of personal pride in our accomplishments."

The Library Board echoes these thoughts. Dale Budde, president acknowledges "Gay grew professionally along with the library. We all feel very fortunate to have had her working with us as the library went through its growth."

Says Pat Chanley, children's librarian, "To say that Gay will be sorely missed sounds so trite, but it's true. Some of us have worked with her for seven and a half years. You can't go through so much (referring to the process of the new library) together with such a small group without building some very strong personal feelings."

In addition to planning on spending more time with her family, Gay would also like to volunteer for the American Diabetes Association, something she has wanted to do for some time. To keep a hand in her profession, she would also like to do some part-time library work. Whatever she does, the people of Bloomingdale wish her the very best. After all, that's what she strove to give us.

Gay's last day will be December 18. The new administrative librarian, Mary Rodne, begins December 15. The Almanac will introduce her next issue.

# AUTOGRAPH AUCTION SUCCESS

When a handful of German settlers decided to form St. Paul Church on their farmland, now known as Bloomingdale, they may have only dreamed that more than 100 years later, their labors of uniting the community through its church would be a reality.

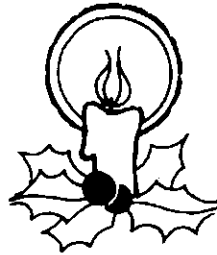


## FLYING HIGH WITH FASHION

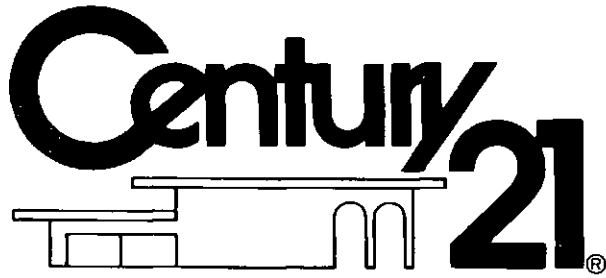

# FROM THE DESK OF THE SUPERINTENDENT

During the past three years the administrative staff of the Marquardt School District 15 has formulated district goals which reflect input from the Board of Education, teaching staff, and community. For the 1986-87 school year the focus of these goals continues to be the maintenance and improvement of the educational program provided for the Marquardt students. In support of the educational program there will be a continuation of the energy conservation program presently in place. This program seeks to reduce energy costs while providing a comfortable atmosphere and a healthy environment in which our students can learn.

A continuing goal in the area of finance will be the annual application for the Certificate of Excellence in the area of accounting and business practices. As the public is aware, the Marquardt School District received this award during the 1985-86 school year, after three years of preparation and study. However, as a requirement of this award each district must continue this excellence in reporting in order to maintain its standing. Another finance goal is to review computer hardware and appropriate software programs designed for school finance and fund accounting. This goal would culminate in the purchase of a new computer system and software with the development of a successful transition and implementation program.

The curricular areas identified for this year represent a continual assessment of all content programs. In the area of Language Arts, district committees will seek to adopt a new spelling program which promotes the activities of the most recently adopted Language Arts textbook. In Mathematics there will also be a district committee to determine if a new Math program should be adopted and, if so, review selected publishers in anticipation of an adoption. Other curricular goals include: Health - review and refine the program "Health Skills in Life;" expansion of the computer program to include the primary levels, emphasizing Kindergarten through Grade 2; implementation of an effective staff development program which provides meaningful staff development activities; utilization of the new teacher evaluation system, focusing upon the role of the consulting teacher as outlined by the School Reform Bill 730; and to continue the emphasis upon improved School/Community Relations, focusing on the construction and dissemination of a quarterly district newsletter.

Lastly, in order to keep abreast of the current and future needs of our district, two districtwide committees composed of parents and teachers will be established for the purpose of addressing a Kindergarten/Early Childhood Center and the integration of 6th grade students within a middle school concept. The establishment of these study committees is in accordance with the recommendations of the Strategic Planning Committee.

With the successful completion of these goals, the educational program of the Marquardt School District will continue to prepare students for the achievement of their full learning potential.

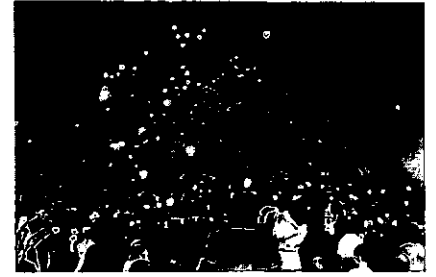

## LAUNCH FOR LIBERTY



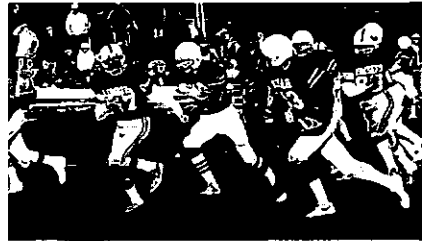

Cards from the balloons have come back from as far away as Massachusetts and Nova Scotia, Canada indicating those who found the balloons wish to purchase a copy of the book.

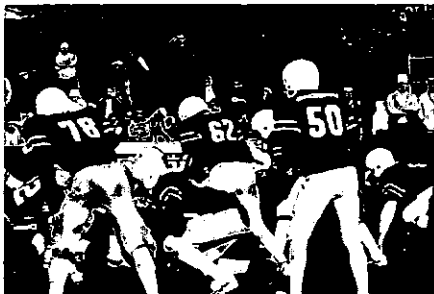

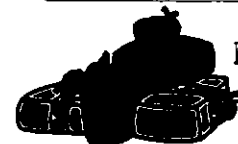
