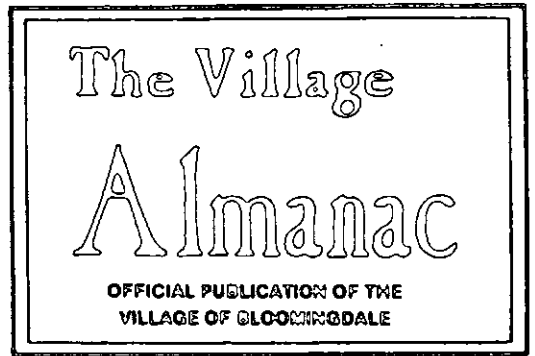

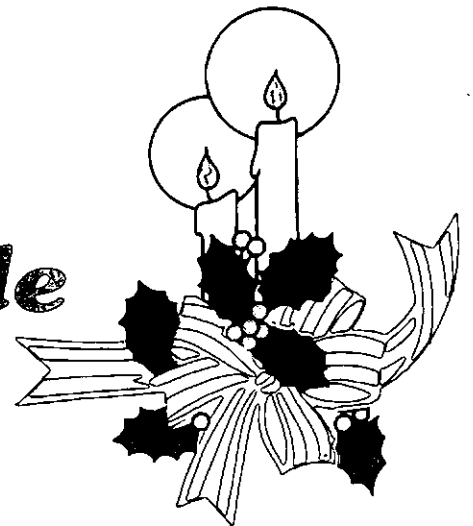
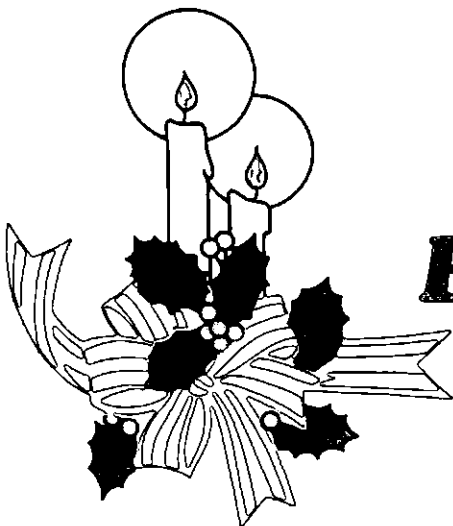

## NEED A RIDE?

Bloomington Township recently entered into an intergovernmental agreement with the Village of Carol Stream to provide dial-a-ride service to all Carol Stream residents Monday thru Friday 9:00 AM to 4:00 PM. Since Carol Stream has Bloomington, Wayne and Milton Townships within its boundaries, this greatly expands the transportation service area.

Although Bloomington and Milton townships are divided by North Avenue, the new southern boundary will be Geneva Road. Service will include the Wheaton Medical Clinic and Wheaton Eye Clinic. Central DuPage Hospital is available for an additional cost of 25¢ to the regular fare.

## RYAN GUEST AT NEIGHBORHOOD WATCH

The topic for the September 25 meeting of Bloomington's Neighborhood Watch Program was the Criminal Justice system, in honor of the 200th birthday of the signing of the Constitution. The guest speaker for the evening was DuPage County State's Attorney James Ryan.

Ryan was able to not only inform the audience of the Criminal Justice system as it is applied in DuPage County, but also talked about several programs run by the DuPage County State's Attorneys office. Among these are the Victim/Witness Assistance Program, the DuPage County Children's Center and the School Substance Abuse Program, which his office brings to high schools and junior high schools throughout the county.

Since taking office in December 1984, Ryan has organized the Gang Crime Task Force, the Domestic Violence Task Force and the DuPage County Children's Center. He is on the advisory committee for the Coordinated System Response Project of the Department of Children and Family Services, a member of the Adult Advisory to the Department of Corrections and is chairman of



James Ryan ponders a question asked by Neighborhood Watch members.

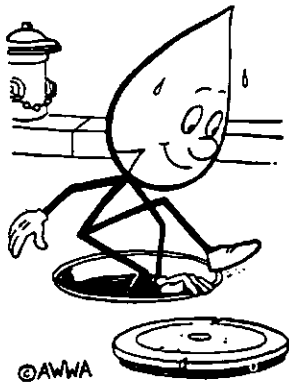
the Narcotics Subcommittee of the Law Enforcement Coordinating Committee for the Northern District of Illinois. Ryan was also recently awarded the DuPage County Police Chiefs' Award for Distinguished Service and Prosecutorial Excellence.

The Bloomington Neighborhood Watch is an organization whose goal is to inform the residents of Bloomington of crimes occurring within Bloomington, and to educate them as to crime prevention measures they can take to deter criminals from victimizing them.

Ideally, the program should have representatives from every area of town. Although the program has grown tremendously since its inception over three years ago, there are still areas of town not being represented. Meetings are held the last Friday of every other month at 7:30 p.m. at the Village Hall. The next meeting will be held January 29th and will feature a speaker from Citizens Against Crime. ## THE WATER LINE...

**What are those round metal caps located in my front yard for? Can I cover them up? Nobody ever uses them.**

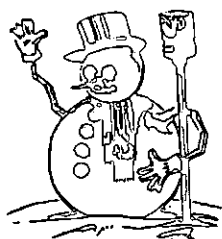
Have you ever been out mowing your lawn when you came across a round, metal cap in your yard? Well, you might like to know they are there for a very good reason. Some of these are shut-off valves for the water service going to your home; others are valves for the water mains on your street. Commonly, these are called b-boxes or valve boxes.

Sometimes problems develop that make it necessary to shut the water off. If there is a fire in the home or a leak, it is sometimes the only way to shut off the water to protect your property from additional water damage.

When water mains break, the valves allow water division personnel to shut off the smallest section of water main to reduce the number of customers without water service to their homes.

Another purpose for these b-boxes is to shut off water when the home is vacant. This is especially important during the winter months where heat has been shut off in the home and broken pipes can occur.

So remember, the b-box will be there when needed to protect your property from water damage. Help us by keeping it from being damaged or covered up!



# FROM THE DESK OF THE SUPERINTENDENT

### LEGISLATIVE BREAKFAST

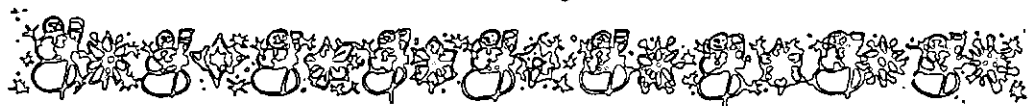
For the fifth consecutive year the legislative Committee of the Marquardt School District 15 Board of Education, headed by Robin Rose and Cora Bruhl, has sponsored a Legislative Breakfast. This year's breakfast featured Hal Seamon, Executive Director of the Illinois Association of School Boards.


As in the past four years, representatives and senators from the Glenbard attendance area were invited to attend this breakfast along with District 15 parents and the superintendents, Board presidents, and legislative chairpersons from approximately seven school districts.

In his remarks, Seamon indicated that there is no apparent visible crisis in the schools today and, as such, it would appear that the state legislature will not provide additional funds. He emphasized that it is the responsibility of parents and educators to provide the necessary evidence that there is indeed a financial crisis facing Illinois school districts. He stressed repeatedly that individuals must contact the members of the General Assembly and inform them of their feelings. Parents and educators must be specific in documenting the reductions in teachers and programs.

Following Seamon's comments, he invited those area legislators in attendance to express their views. Both State Senator Fawell and Representative Parke said that "...the problems that we, as legislators, face is one of too many demands and too few resources." It is obvious to the Glenbard area superintendents that their programs have lost money. Some programs were cut significantly, based upon the amount of money received from the state. Others, because of a larger financial base, receive less state aid money and consequently were not affected as drastically. However, it was apparent from both Seamon's remarks and those of the area legislators that the subject of increased funding, in the form of a tax increase, will be the most important issue facing the legislators in either the Fall Veto Session or in the Spring Session.

The districts in DuPage County face an interesting dilemma in that money from a tax increase will not completely return to its districts but will be spread among all the school districts within the state. Therefore, as a school district located within DuPage County, it would seem more beneficial if the categorical areas of transportation, special education, and other mandated requirements were fully funded along with an increase in general state aid.

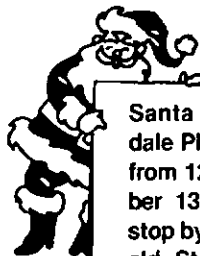

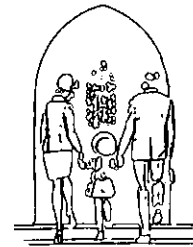

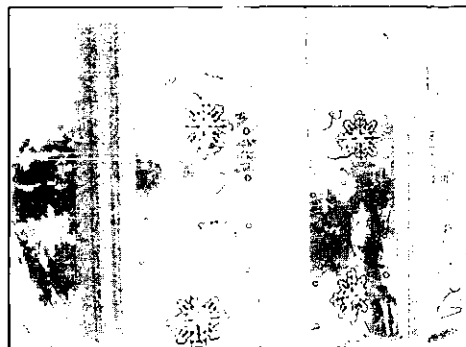

## FRIENDS OF THE LIBRARY

A monetary donation to start a compact disc collection tops the list of recent donations to the Bloomingdale Public Library from the Friends of the Library. Due to the Friends' generosity, the library will soon have compact discs available for Bloomingdale residents to check out. The starting collection will be comprised of classical music. In future purchases, other types of music will be included. Keep watch in December for the commencement of this new service.

Another recent Friends' donation was a new typewriter with correction for patron use. The typewriter is available free of charge to all patrons 18 years old and over. If you want to use the typewriter, just call or stop at the Reference Desk and reserve a time.

And still another recent donation to the library from the Friends included a 4-piece silver-plated coffee service and two silver-plated serving trays. The gift was purchased by the Friends to honor former Administrative Librarian Gay Nass for her seven years of service to the Bloomingdale Library and her work with the Friends. The silver-plated service will be used for special activities of the library.

## LIBRARY SERVICES

In addition to lending books and answering questions, the library offers a variety of services and programs you may not know about. While you're here you can register to vote, consult a babysitters' file, borrow a camera or an engraving pen, and use a magnifying lamp. 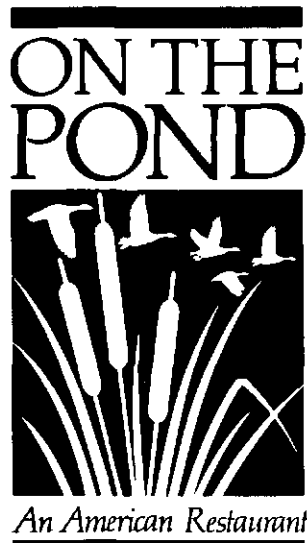

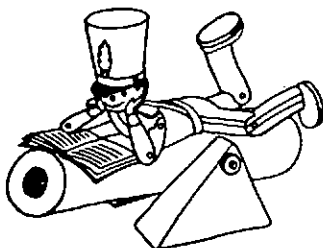
### "Eskimo Carvings & Prints"

The Canadian Eskimo artists live a semi-nomadic existence along the barren shores of Hudson Bay and Baffin Island. Their lives are governed by hunting and in their art we see the life through the eyes of the hunter. Since wood is scarce, the Eskimo uses steatite (soapstone), amphibolite and many of the harder stones, as well as other materials such as narwhal ivory, walrus tusks and various types of bone and horn.

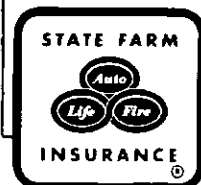

# GUEST COLUMN

The following column comes to us courtesy of Dr. John E. Ruch of the Bloomington office of the Arlington Chiropractic Clinic, 220 E. Lake Street.

## "OSTEOPOROSIS"

Osteoporosis is the inexorable loss of bone mass as we get older, and is the most common disorder of the skeleton. Decline in bone mass begins in the twenties. From the start, women lose more bone than men. In fact, by the age of 80, a woman will have lost 47% of her trabecular (porous) bone, and a man only 14%. The bulk of this loss occurs in the first 5-6 years following menopause. Around the age of 65, the rate of bone mass decline slows down.

There are two types of osteoporosis; primary and secondary. Secondary osteoporosis is due to an identifiable single cause, usually drugs or disease, and affects men, women and children equally. Primary osteoporosis is the most common, and what we are concerned with in this article. It's due to a variety of influences, including heredity, hormones, nutrition and lifestyle. It is also known as postmenopausal, and is more prevalent and more severe in women.

The spinal vertebrae and upper part of the femur are the most susceptible areas. The vertebrae are usually the first to show evidence of the disease. They become porous and weak, and with time may collapse. This weakening and collapse of the vertebrae can result in the "dowager's hump" often seen in older women, as well as a significant decrease in height.

Twenty five percent of women will suffer from osteoporosis. Not all women are equally susceptible. Certain risk factors, some controllable and some not, may predispose you to osteoporosis.

Some of the non-controllable risk factors are: age at menopause, family history, ethnic differences, bone structure and disease processes. The earlier the onset of menopause, the greater the risk of developing osteoporosis, simply because more years are spent without the protective influence of estrogen. A family history of osteoporosis may indicate an increased susceptibility to the disease. Small bone structure, fair skin, and low body weight also seem to add to the risk. Black women are far less apt to develop osteoporosis, perhaps be-

cause of an inherently larger build, and oriental women seem to have a pronounced susceptibility. Certain diseases, such as diabetes, rheumatoid arthritis and endocrine disorders predispose to osteoporosis.

The risk factors that can be altered include the use of oral contraceptives, the number of children, and diet and exercise habits. One of the positive things about using oral contraceptives is that the risk of osteoporosis may be slightly decreased. Childbearing, on the other hand, may increase your risk - IF your diet during pregnancy is deficient in calcium. The body will preferentially supply the developing child with the calcium he or she needs, depleting the mother's stores. However, this is easily preventable by eating a balanced, calcium-rich diet while pregnant, perhaps with calcium supplements.

In fact, in women of any age, diet and lifestyle appear to be major factors in the prevention of osteoporosis. Most American women eat a diet significantly deficient in calcium. By instituting the following suggestions, the epidemic of osteoporosis may be stemmed.

The initial place to begin is with diet. The average woman should obtain 1000 mg of calcium daily before menopause, and 1200-1400 mg after menopause. This can be accomplished by dietary means and supplementation.

Milk is one of the best ways to obtain calcium. Not only does an 8 oz. glass of milk contain about 300 mg of calcium, it is fortified with vitamin D to increase absorption and contains lactose, a sugar that also aids in calcium absorption. Hard cheeses, tofu, red salmon, sardines, nuts and broccoli are also good calcium sources.

Calcium supplements are best absorbed in small doses, so should be spaced out, and taken with milk or yogurt. One third of the daily allotment should be taken right before bedtime. Dolomite or bone meal are not suggested as calcium supplements, as they contain toxic materials.

In addition to calcium, adequate vitamin D, magnesium and manganese should be supplied. Vitamin D enhances calcium absorption, and magnesium and manganese aid in utilization. 400 IU of vitamin D are necessary daily. This can be obtained through 15-20 minutes of sunshine a day, in supplements, and in milk as well as certain other foods, such as fatty fish, butter, eggs, and liver. Be cautious, however, vitamin D may be toxic in higher doses.

Magnesium should be supplied in the same amount as calcium - preferably taken simultaneously. It is found in nuts, whole grains, dark green vegetables, lentils and seafoods. Manganese should be supplied at 10-20 mg/day and is found in the same food sources as magnesium.


Certain dietary factors appear to interfere with calcium absorption and metabolism, and so should be controlled. Excess protein may increase calcium excretion. Red meat should be limited to 2-3 times/week. Caffeine and alcohol should be taken only in moderation, and eliminated by those at high risk. Calcium supplements and major dietary sources of calcium should not be taken with a high fiber meal, as fiber tends to decrease absorption. Vegetarians have been found to have less osteoporosis than meat eaters. Stress can increase excretion and decrease absorption of calcium, so calcium should be increased when under stress. High phosphorus foods such as red meat, cola drinks, and Brewers yeast should be limited. Smoking can interfere with calcium utilization, and so should be stopped or at the least reduced.

# SHOWCASE SUCCESS

Exercise is thought to be one of the primary means of prevention. Putting stress on the bone stimulates them to remain strong. Weight bearing exercise such as walking, jogging, bicycling, hiking, rowing and jumping rope, done consistently 3-4 times/week, may be the key to maintaining bone strength throughout life.

Once these changes are instituted it is important to know how the program is working for you. Regular tests for bone mass can help you - and your physician - monitor your progress. These are several options available, and your doctor can help you decide what's right for you.

A screen for bone mass should be done once in the 30's and 40's, followed by 2 or 3 annual assessments during menopause, and then regularly until the age of 65. This will help you know at what rate you are losing bone mass. In non-responsive cases, estrogen replacement therapy may be indicated. Estrogen is very effective in preventing bone loss, but does have some risk factors.

In summary, osteoporosis is not an inevitable consequence of aging. YOU can have an impact on the health of your skeleton - isn't it worth the effort?

*Bone scan Radiodensitometry is performed at the Arlington Chiropractic Clinic routinely for assessment of osteoporosis and bone loss.*
