# MAYOR'S DIRECT LINE

"Joint Action to Stop New Runways at O'Hare"



The suburban municipalities surrounding Chicago recently learned there has been discussion of adding at least one more runway at O'Hare International Airport.

On November 30, 1989, I participated in a Suburban O'Hare Commission strategic meeting to unequivocally oppose the construction of any new runway or runways at O'Hare and to support a permanent ban on such construction.

The addition of new runways dramatically increases the average daily noise level in the Village of Bloomingdale, which is already experiencing an adverse impact of O'Hare noise and air pollution.

Because additional runways would adversely impact both the environment and the quality of life of the Village of Bloomingdale's residents, I recommended the Environmental Concerns Committee formulate a recommendation to the full Board in regard to this concern.

In that regard, on January 8, 1990, the Village Board voted to join the Suburban O'Hare Commission at a cost of fifty cents per capita per annum, or approximately \$8,000 per year. The Village has the necessary funds to join SOC now. Eight thousand dollars is a small price to pay to ensure that the quality of life for our present, as well as future residents, is not impaired from future air and noise pollution generated from O'Hare Airport.

At that same meeting, the Board also adopted a "RESOLUTION SUPPORTING A PERMANENT BAN ON CONSTRUCTION OF NEW RUNWAYS AT O'HARE INTERNATIONAL AIRPORT, THE CONSTRUCTION OF A THIRD MAJOR AIRPORT IN NORTHEAST ILLINOIS AND THE CONSTRUCTION OF THE ELGIN-O'HARE EXPRESSWAY."

In my opinion, the only viable alternative to facilitate our air transportation needs now, and for the future, is the construction of a third airport. It's incumbent upon all parties involved to unite together to ensure that the construction of a third airport becomes a reality in the new decade.

We feel becoming an active member of the Suburban O'Hare Commission is the most credible and effective way to have an impact on how we are affected by O'Hare International Airport in the future.

# 9-1-1

In the April, 1989 issue of the Almanac, the Mayor's Direct Line explained the referendum question regarding a surcharge for the purpose of installing an enhanced 9-1-1 system. Voters approved the surcharge and since November phone customers have been charged an additional 50¢ on their monthly bill.

The new system, which will be in operation by April, 1991, will enable phone customers to dial the three digit number and be automatically directed to the correct department in an emergency.

The 50¢ surcharge is being used to cover the cost of the necessary equipment and research needed to commence the program. If you have any questions contact the Emergency Telephone System Board at 682-7288.



# TREE TRIMMING

You may have noticed over the past month, Village crews out trimming Village parkway trees in some areas. There have been some inquiries and concerns about the trimming of these trees.

We would like to address the largest concerns and inquiries in this issue.

QUESTION: Are the maple trees in stress from bleeding due to the trimming?

ANSWER: No. 80% of this bleeding is excessive water build up from winter stor-

age. This bleeding will stop three to six weeks after pruning and will

not harm the tree.

QUESTION: Why are we trimming so high?

ANSWER: Once a tree grows a parent stem (limb), that limb remains at that identi-

cal height for the duration of the life of the tree. The lower limbs take most of the nutrients that are required for proper growth for the crown (top) of the tree. Not only is this helping the crown of the tree to grow, but removing those lower limbs will insure safe passage for motorists and pedestrians. It is also much safer for a tree to trim these limbs

while they are smaller.

QUESTION: Should these cuts be covered with tree dressing or paint?

ANSWER: No. Extensive studies by the U.S. Forest Service and by the U.S. Depart-

ment of Agriculture have shown conclusively that pruning paints and other types of tree wound dressings have never had any benefit for tree wounds. In fact, the reverse is true. In most instances such applications increase the rate of decay of the heartwood behind the application, while at the same time retarding callus growth, which is the new wood that grows and "closes over" pruning cut. Pruning wounds left open to the air and the sun callus' faster and incurs the least amount of

heartwood decay to the parent stem.

QUESTION: Are these workers trained for this service?

ANSWER: Yes. All Village employees performing tree pruning have been trained

to do so properly.

QUESTION: Are the wood chips from the tree trimming available?

ANSWER: Yes. Wood chips are available to residents at the Public Works facility,

311 Glen Ellyn Road, on a first come first serve basis.

# NEW POLICE OFFICER ADDED TO STAFF

Duane Stuart Kroll is the newest Bloomingdale Police Officer after being sworn in at a Village Board meeting last month. The young man holds an Associate of Arts degree from Harper College, having majored in criminal justice. He also spent a year at Western Illinois University majoring in law enforcement.

He says he first became interested in a law enforcement career taking an advanced study program at Harper while still a high school student. He says he enjoys the tactical side of the career.



Kroll is a member of the U.S. Marine Corps Reserve, serving as a corporal through the end of this month.

Kroll graduated from the Chicago Police Academy on January 17. He received the top physical skills award for his performance in self-defense, arrest tactics, fitness and agility, beating out 88 other police recruits.

He is presently serving his 13 weeks of in-service training with four field training officers in our department.

# A DEPARTMENT BUILT ON TEAMWORK

The words "team work" best describe the spirit of the members of Bloomingdale's Building Department. The six individuals who make up the staff are hard working energetic individuals who enjoy their jobs.

The daily activities performed by the building department, are quite varied and the collective efforts of the staff, coupled with the high standards set for construction in Bloomingdale help make this a nice place to live.

Joe Stella, currently a consultant for the Village, rejoined the staff in 1986 after his retirement from the Village in 1981. Joe is very happy to be back with the building department and feels that currently we have one of the strongest teams he's seen in his twenty-year experience with the department. Stella is very satisfied with the progress Bloomingdale has made during his tenure and feels that the secret to the town's success has been "orderly growth".

One key to maintaining that orderly growth lies in the responsibility given to the Village's building inspectors who make sure that the entire construction process meets with national and local codes, regulations and ordinances.

As Building Commissioner, it is the job of Mike Gricus, to handle commercial inspections, review plans, and attend developer meetings, as well as issue occupancy certificates and handle resident complaints.

Like Stella, Mike is very happy with the current staff of the building department. "Each of us knows at least a little about everything, and that includes, filing, the phones and working the desk. So if need be, we can double up on duties." The department prides itself on being a very efficient, almost self-contained unit.

Mike works with each new employee for a three-month period, so there is time for learning all the ins and outs of the department. He also says because they work together, so closely, he has no problem backing up staff members, should a problem arise. Len Deibel, whose responsibilities include all annual business inspections, as well as residential inspection and plan reviews, says his job is interesting and unpredictable. He enjoys watching a project evolve from plan to final product. "One cannot help but be impressed by the character of Bloomingdale. The Village is maintained daily to keep it that way," says Deibel.

That daily maintenance is partly the job of Tim Finnander, as he handles all property maintenance inspections, making routine trips through town to keep an eye on our appearance. Fences, pools, decks and room additions must also be inspected. These are also Tim's responsibility who says he enjoys working outside and interacting with the residents.

Steve Mertes, who handles a large portion of the residential inspections, says being a building inspector for the Village of Bloomingdale is the best job he's ever had. He enjoys the responsibility of being part of the construction process.

Judy Ritchie is the newest addition to the building department. Her many duties include issuing permits and certificates of occupancy, scheduling inspections and handling the many phone calls received daily by the department.




Residents who are contemplating building a new home or making changes to their existing dwelling should first contact the Village in order to familiarize themselves with the codes and ordinances which pertain to their project.

The next step is to have plans drawn up for the project and have them approved thus allowing a permit to be issued. Once your project has commenced, a series of inspections must be performed, (the number varying from project to project), in order to verify that your project is proceeding as planned.

Mike Gricus predicts this will be another very busy year for the building department as commercial development takes the forefront in Bloomingdale in 1990. In 1987, 700 building permits were issued. Last year, that number was 1200.

In addition to keeping up with the workload, staff members will continue to attend seminars to keep abreast with changes in codes. All members of the staff are working on their national certification which will add even more to their credibility in the field.

Watching this team in action makes it very evident there is a lot of talent and a great deal of pride involved in getting the job done. We're happy to have had the chance to put them in the spotlight this issue.

# DISTRICT 15 **BOARD MEMBERS** RECEIVE RECOGNITION

Local school board members are the backbone of educational governance in Illinois. The Illinois Association of School Boards is authorized by the School Code "to educate school board members as to their duties and responsibilities so as to improve the management of the public schools." IASB's Development and Leadership Program is designed to fulfill that responsibility.

The purpose of the program is twofold: 1) to encourage school board members to develop a high level of boardsmanship skills and knowledge, and to recognize those who do so; 2) to encourage school board members to take a leadership role in public education in Illinois, through participation in IASB activities. An example of such an activity is the Annual IASB Conference held in downtown Chicago during the month of November each year. The conference usually begins on Friday and ends on Sunday morning. There are many workshops, guest speakers, and exhibits scheduled which a Board member may choose to attend. Each Board member registered for this conference receives 25 quality points. In addition, if you served as a panelist at this conference - which Mrs. Bruhl, Board President, did in 1988 - you would receive an additional 15 quality points.

Four of Marquardt District 15's seven Board members have recently been recognized by the Illinois Association of School Boards for their participation in IASB activities that contribute to professional development. Dick Abel, who achieved Level I recognition (40-79 credits), received a framed certificate; Marie Schmidt and Robin Rose, who achieved Level II recognition (80-119 credits), received a framed certificate and an IASB stick pin: and Cora Bruhl, who achieved Level III recognition (120-199 credits), received a crystal paper weight in addition to the certificate and stick pin.

Abel, Schmidt and Rose were presented with their awards by Bruhl, Board President. Her award was presented by Lawrence Golden, Superintendent of Schools. All of the awards were presented at regularly scheduled meetings of the Board of Education.

Congratulations to these Board members and all Board members who have volunteered countless hours of their time in order to ensure that the students of District 15 receive the highest quality education.

# **BLOOMINGDALE SCHOOL DISTRICT 13 NEWS**

Mike Hovde, President **Board of Education** 

Bloomingdale Elementary School District 13 is continuing to grow. As the new houses and townhomes are being built in the district, our enrollment is increasing. In just two years, our student population has grown from 1204 to 1339. During this past month of January, we enrolled eleven new students.

In December, the district updated its enrollment projections. This new study projects an opening enrollment of 1390 students for the next school year, nearly 100 students over our facilities' educational capacity. We expect to have over 1580 students within the next five years.


How are we going to handle this growth? The Board of Education is committed to providing quality education to all of our students. To maintain quality with this increased enrollment requires the construction of a new school and an addition to DuJardin School. Eventually a referendum must be passed to fund this new construction.

In the interim, the Board of Education will continue to lease portable classrooms to ease the overcrowding. We currently have two portable classrooms at Central and have approved the procedure for leasing two classrooms at Du-Jardin School for next year. It is possible that we may have to lease two more classrooms for DuJardin and two for Westfield by the time school opens next fall.

Portable classrooms have a severe limitation for solving our overcrowding problems. By state code, they can only be used for classroom space for five years. If we do not pass a referendum this next year, the two portable classrooms we are currently using at Central will have to be vacated before a new school is

The Board of Education has taken other steps these past few months to help solve the overcrowding problem. We have now received title to the 7.5 acre school site on Springfield Drive just south of the new park. This will be the location of the new school when it is built. This site was donated to the school district by the developer of the Stratford Square area. Also we have sold Tompkins Park to the Village of Bloomingale. The proceeds of this sale will be going into the construction fund to help pay for the new facilities.

In the near future, Bloomingdale Elementary School District 13 will have to build a new school and add on to DuJardin School. # **INTOUCH PROGRAM**

Lake Park High School has had activities for substance abuse prevention for approximately three years. The InTouch Program has been in operation for the last two years and has served as a coordinator of the various activities held previously.

The chairperson for the program is Dr. Jack Bils, the Assistant Superintendent for Personnel Services at the high school. Dr. Bils works with many people from the community who have expressed an interest in working with such a program.

The team coordinates consist of students, Board of Education members, counselors, teachers, parents, representatives from school administration, church, the police department, area seven InTouch, and Bloomingdale Township Committee on Youth members.

Funds for the program flow from the federal government through the state due to the Drug Free Schools and Community Act which was passed a couple of years ago. The act was designed to provide financial and other types of assistance to deal with substance abuse prevention activities for our youth.

"We hold chemical awareness nights for students who compete in sports in our high school. We try to get across the Just Say No Message," stated Bils. "At these awareness nights we have a combined session for students and parents, then we split into two groups, one for the parents and one for the students.

Following these individual sessions, the students go to an area with the coaches or the sponsor for a particular activity and meet with them. This type of awareness night is presented three times each school year and students in sports or other activities need to attend one of them."

The InTouch Program's activities also include a safe-home network of families. These families are committed to wholesome, chaperoned activities for their children and are committed to not allowing alcoholic beverages or any other drug to be consumed by minors in their homes.

A Speakers Bureau is also made available to various clubs and organizations to speak about the program and related topics. Students go to the junior high schools to talk to the students about the national concern of helping youngsters say no to drugs.

Another facet of the program is to send three to six young adults to teen training institutes during the summer. They attend the downstate Illinois Teen Institute for one week through funding provided by the Drug Free Schools and Community Act.

"We feel that we have been able to reach hundreds of kids through our substance abuse prevention activities at Lake Park. We feel that we have been very successful," said Bils.
