

# Bloomingdale Old Town

here's a lot of new stuff going on in Old Town Bloomingdale these days. For starters, a large portion of the historic turn of the century shopping district recently came under new ownership. Shopkeepers and other tenants are optimistic this change of hands will fuse innovative ideas with the historic past generating a rebirth of the area.

One of the believers in the future of Old Town is Bloomingdale resident Edward Levato. As general partners of the Bloomingdale Old Town Partners, Ltd., he and his law partner, Keith Kotche, report there are some very definite plans for the rejuvenation, plans that promise to have a positive impact on the entire Village.

"It will be a gentle transition," said Levato. "Our first priority is to bring the vacancies down and then we plan to restore Old Town to what it was meant to be - a business district of unique shops very much like Long Grove."

Levato says owners plan to give the business district a make-over. He hopes to attract substantial tenants, including the Chamber of Commerce, to lend stability to the project. Levato & Kotche believe in the project - so much so that they plan to relocate their offices to The Mansion in the heart of the center.

Another sure sign of the rebirth is the re-emergence of a new Old Town Merchants Association. The group elected new officers at its first meeting in January and is excited about the plans they are formulating.

Also in the planning stages is a municipal green-grass open area, on the southeast corner of Franklin and Third. Spurred on by the Old Town Commission, the Village recently purchased one half of the land for the three-quarter acre parklike area. Conceptual plans for the open space include a granite fountain, brick paver walks and wooden park benches. Construction would be done over several years.

With the spring thaw in sight, shopkeepers anticipate shoppers will find more to enjoy as they stroll through the historical backdrop. The April issue of the Almanac will feature what exactly you can find in Old Town.

### TREES, TURF, AND MULCH

Most trees used in urban and other landscaped areas originated in forests with rich, fertile soils and surface layers covered with decomposed leaves and other organic matter. Competition did come not from grass, but from other woody plants and scattered herbaceous plants. Yet in a managed land-

scape, these same tree species are grown in compacted, disturbed soils with aggressive turfgrass competition over the entire root zone.

With the competition of grass and the absence of a litter or humus layer on the soil surface in the root zone of a



tree, development of its absorbing or fine roots is restricted. Trees with a poorly developed fine root system will be smaller and less vigorous. As a result, they will be more sensitive to environmental stresses such as drought and nutrient deficiencies. These effects may occur on any-sized tree but are most evident on young trees. Supplemental watering and fertilization may help overcome some of the reduced tree growth but not all of it. In fact, the summer irrigation required to maintain turf may be detrimental to trees.

Mowing and weed management in turf can also lead to tree problems. Mechanical bark damage, especially on the trunks of young trees, from lawn mowers and string "weed eaters" can be very extensive. Similarly, many herbicides or weed killers that are used in turf can kill or cause severe damage to trees whose roots are within the treated area.

Mulching an area with two to four inches of organic matter such as com-

posted wood chips, bark, or peat moss creates a soil surface condition much like the tree would have in its native forest habitat. To be most effective mulch should extend as far as possible from the base of the tree, at least two feet for young trees and when possible two to three times the branch spread.

Currently, there is a practice of stacking soil or mulch up on the trunk of the tree. This should not be done as is will lead to canker and decay. Also, plastic should not be used because it interferes with the exchange of gases between soil and air.

Numerous studies have shown that trees and their roots grow considerably better in large mulched areas, because the mulch improves the aeration in the upper portion of the soil, improves soil water retention, and moderates the soil temperatures. Further, as the mulch decomposes, nutrients become available to the tree.


District 13 staff are busy throughout the year working on committees to improve programs offered in the schools.


The Literacy Committee, the first committee that has enlisted parent involvement, is reviewing the results of a staff survey regarding reading, writing, and language arts instruction.

### LAKE WATER UPDATE

### LAKE WATER SUPPLY MAIN LEAK

On January 22, 1993 a leak developed in the 90" transmission main that delivers lake water from Chicago to the DuPage Water Commission's Facility in Elmhurst.

All communities were unable to purchase and distribute water from the Commission for three days. The emergency required all communities to start up their well water supplies.

The Village was prepared to do so and shortly after being notified that the lake water was being shut off, the Village Service's Utility Division started the well supply. The first step was to waste water to assure that the water was clear and then to collect water quality samples for analysis at the lab. The samples were determined to be satisfactory and then the wells were brought on line.

Residents may have noticed slight differences in the well water compared to lake water during the period between Friday, January 22 at 9 pm and Monday January 25 at 9 am. Follow up sampling was completed to assure water quality was maintained throughout that period. As of January 25th we've been reconnected to the lake water supply and the wells have once again gone to standby status. At no time during this event was the Village water system in jeopardy. The water was and remains safe for all consumers.

### CHANGES IN LAKE WATER TEMPERATURE

Some residents may have noticed that the temperature of the lake water we now receive is colder than the well water we provided prior to our connection to lake water. In fact, the water from Lake Michigan runs about 20 degrees colder in the winter than well water.

Because of this hot water tanks will work longer to heat the water to the temperature setting on your water heater. You may also wish to insulate water pipes that are in colder locations in your home to protect them from freezing. These would be areas like the garage, basements and other unheated areas, and precautions should be taken to allow warm air to reach these areas if possible.

### LEAD AND COPPER SAMPLING UPDATE

The Village has received the results from the samples collected for lead and copper during the initial phase of the Lead and Copper Sampling Program.

The results indicate that the Village is in compliance during the initial phase of sampling. The second set of samples will be collected in March 1993 and will be taken from the same sites as the initial phase. These sites have been selected based on specific sampling criteria established by the Environmental Protection Agency. Once

again the Village would like to thank those homeowners who participated in this program and looks forward to working with them again in March.

### St. Isidore Teens Plan Trip To Guatamala

Thirteen teens, led by Mike Murphy, St. Isidore's Youth Minister, and sponsored by the Diocese of Joliet and the Christian Foundation for Children and the Aging, hope to travel to Guatamala in June.

"This will be a learning experience for our youth," said Murphy, "They will see first-hand that Guatamala is an independent culture with much to offer us. The trip is intended to be a cross exchange between us, recognizing that neither country is superior to the other."

The teens range from 14 to 17 years of age, most have had two years of language but they will be accompanied by adults who are versed in the language, among them, Father Richard Walsh, Director of Religious Education for the Diocese of Joliet, and Fernando Torres, Youth Minister Consultant of Religious Education for the Diocese.

The teens are expected to attend a number of meetings in preparation for the trip. They are being carefully instructed through slide shows, literature and lectures by Father Walsh, who has made this same trip before, concerning health issues, appropriate attire and behavior. Personal profiles will also be taken of each participant prior to departure.

After the trip the teens be given the opportunity to share their experiences with the community.

Those who hope to take this trip are actively seeking sponsors. Ninety percent of all donations they raise will be given directly to the village people. The remaining ten percent will finance the costs of the trip.

This is one of many activities offered to the St. Isidore teen group, roughly 150 strong. The group meets weekly to enjoy a wide variety of educational, social and ministerial activities. For further information, contact Michael Murphy, 529-2588.






